In the Community

Meetings, Associations & Presentations.

Denmark Municipal Court is scheduled for December 1, 2021 at 6:30PM. Court is normally scheduled for the first Wednesday of the month at 6:30PM (subject to change)..

Traffic / Ordinance Enforcement

- Officers use traffic enforcement as one mean to modify, correct and educate operators on dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
 - There were **10** traffic <u>contacts</u> initiated and **4** traffic <u>crash</u> in the Village of Denmark.
 - Of those traffic contacts, **3** traffic <u>citations</u> issued and **10** traffic <u>warnings</u> issued.
 - **0 OWI** arrests / citations.
- Ordinance citations are used to enforce the codes that are specific to Denmark. There were 9 ordinance citation(s) issued.

Administrative / Training

- Chronic Nuisance Properties (CNP)
 - Currently, there are **0** properties deemed a CNP in the Village of Denmark.
- Sex Offender Registrants
 - Currently, 1 Sex Offender was cited for Residency Violations. This citation was issued due to Sex
 Offender failing to file appropriate appeal form with Village SORB prior to moving in. DEO Estano actively monitoring this Sex Offender until seen in front of Village. SORB approved temporary residency until November 8th as this offender is moving to a different address outside of Denmark.

Joint Efforts

- Crime Stoppers
 - Both DEOs continue to monitor anonymous tips that come in through Green Bay Area Crime Stoppers.
 These tips are received at Crime Stoppers through phone or online. DEOs are then forwarded these tips for follow-up.

Information Bulletin

Park hours

- Reminder, park hours for the general public are from 8:00 a.m. 10:00 p.m. No person shall be present in the park after hours. Parking ordinances are also enforced within park after hours.
- * Parking within the Village
 - Reminder, Village Code 289-5(D) states "no person shall park any vehicle on any street, roadway, highway, or alley within the village at anytime for more than 48 continuous hours without movement."

• Parking from the hours of 2am-6am is prohibited from November 1 – April 1.

* Noise prohibitions

 Reminder, Village Code 213-6 states "no person shall make or cause to be made any loud, disturbing, or unnecessary sounds or noises such as may tend to annoy or disturb a person of ordinary sensibilities in the vicinity thereof in or about any public street, alley, park, waterway, or any private residence unless..."

House Check Requests


