# Traffic / Ordinance Enforcement

Officers use traffic enforcement as one mean to modify dangerous driving behavior. **Traffic citations** are issued to gain compliance with the law.

There were 25 traffic stops initiated and 4 traffic crashes occurred in the Village of Denmark in January.

Of those traffic contacts,
- 31 traffic <u>citations</u> issued

- 31 traffic warnings issued

Ordinance citations are used to enforce the codes that are specific to Denmark. There were 8 ordinance citations issued in January.

School bus incident reports are submitted by Lamers Bus to officers. The reports are completed by bus drivers and involve other driver's dangerous / poor driving behavior and violations. There was 1 school bus incident report

in **January**. DEOs follow-up with the drivers of these complaints.

Brown County Sheriff's Office deputies and traffic team continue to add extra patrol and enforcement in the village to assist the DEOs and keep the community safe.

### Administrative

Chronic Nuisance Properties – Currently, there is 1 property that are deemed a Chronic Nuisance Property (CNP) in the

that are deemed a Chronic Nuisance Property (CNP) in the Village of Denmark. The CNP ordinance is found in Chapter 200-8 of the municipal code. DEOs are continuously working with the property owner(s), landlords, tenants, and neighbors to resolve these nuisances. DEOs are also notified via e-mail when a call for service is generated and occurs at these CNP.

Ordinance Amendments – The Village Board approved the

amendment of 2 ordinances in the municipal code at the December monthly meeting.

As a reminder, chapter 213-19 now includes prohibitions of possessing vapor products by minors AND prohibitions of smoking, use or possession of cigarettes, nicotine, tobacco, and vapor products on school property.

Additionally, chapter **208-7** now includes smoking and use of cigarette, nicotine, tobacco, and vapor products prohibited in parks.

Sex Offender Residency - The Village Board took action at the January 6 meeting to amend chapter 240-8 regarding Sex Offender Residency appeals. The Village Board also took action to eliminate the Sex Offender Residency Board (SORB) and take on the as the governing body for sex offender residency appeals. The Village Attorney worked close with DEOs on drafting the proposed amendments with the aim to promote, protect, and improve the health and safety of children in the Village.

## Joint Efforts

Brown County Drug Task Force (BCDTF) – DEO Verheyen and DEO Estano assisted SRO Dzekute and the BCDTF with police service dog drug detection sniffs throughout Denmark High School on January 15.

Investigative Division – Currently, there are 3 open cases with BCSO

investigative division. Both DEOs continue to work closely with, communicate, and assist this division. School Resource Officer -

DEO Verheyen and DEO Estano maintain close communication with SRO Dzekute at the Denmark schools. DEOs assist with students when needed, assist with calls for service, and participate in school events.

# Information Bulletin

**Rummage Sale** – DEOs are assisting in preliminary planning with those involved in the preparation for this year's Denmark Rummage Sale in **May**. As a reminder for this year, there will <u>not</u> be a site location in the village to dump unwanted items for pick-up, following the rummage sale.

Park hours – Reminder, park hours for the general public are from 8:00 a.m. – 10:00 p.m. No person shall be present in the park after hours.

Parking – Reminder, there is no overnight parking on village streets, roadways, highways, or alley within from 2:00 a.m. – 6:00 a.m. until April 1. We appreciate your compliance in this, especially during winter months.

Also, remember Village Code 289-5(D) states no person shall park any vehicle on any street, roadway, highway, or alley within the village at any time for more than 48 continuous hours without movement.

**Road closures** – Reminder, Hager Road is closed and will not be open until construction is complete in 2020. This hard closure began on October 10, 2019.

### House Check Requests -

There were 3 house check requests in January.

Are you leaving town for the weekend? Taking a Spring Break vacation? Traveling for the Holidays?

Stop in at the Village Hall to fill out a House Check Request form (or) it can be located on the village website. These forms are turned in to the DEOs and documented.

DEOs will provide extra patrol to your house / property while you are away. These house checks offer extra supervision over your home and provide DEOs information on who to contact while you are away as well as what normal activity to expect.






