- There were 0 OWI arrest made during the month of May.

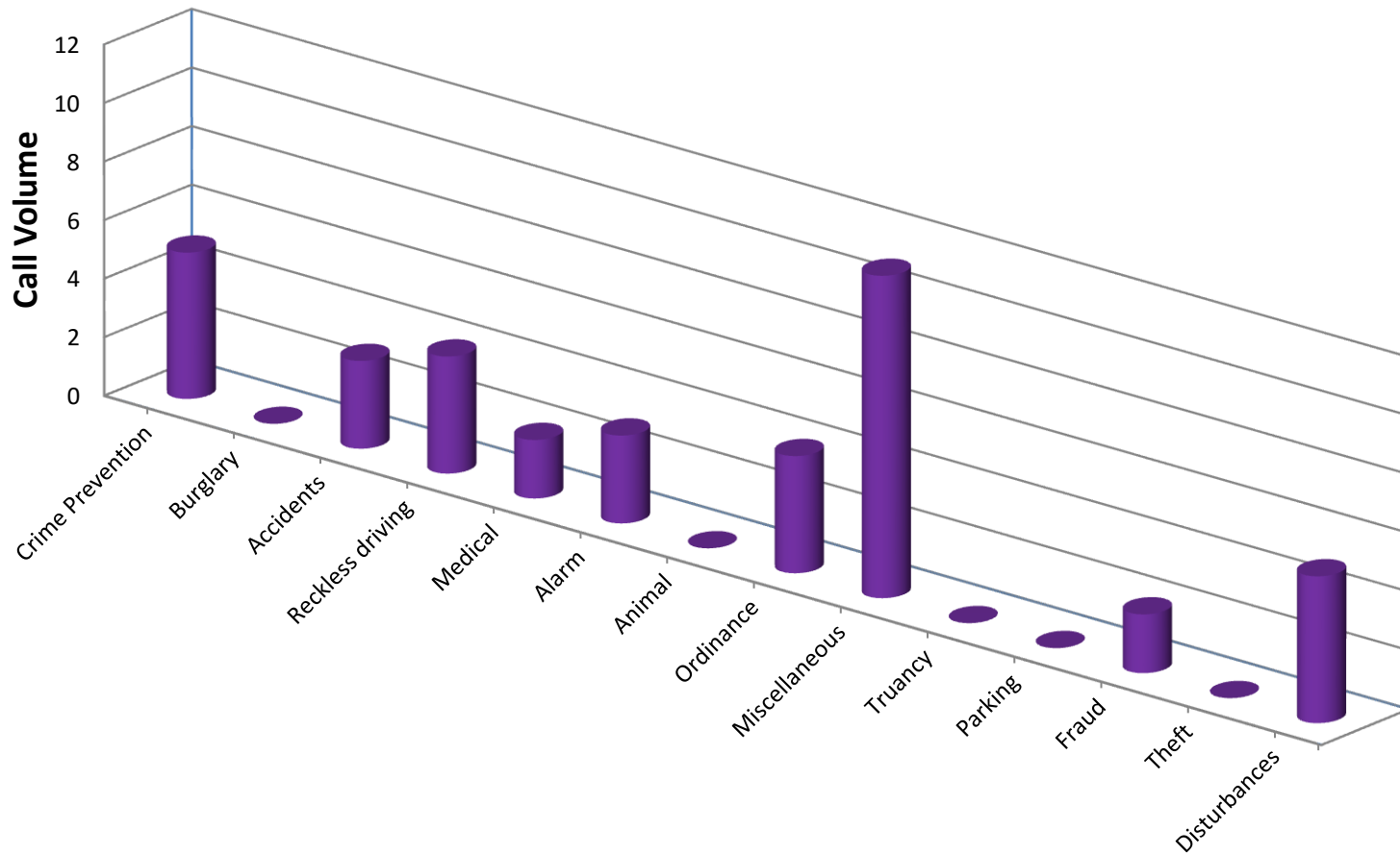
DEO'S IN DENMARK

- 06-27-16 to 07-01-16 DEO Dzekute attended the Basic SRO School in Kenosha that was put on by NASRO (National Association of School Resource Officers). I learned a lot and plan on putting it to good use during this next school year.
- On 07-02-16 DEO Delebreaux found the concession stand at the Highridge ball diamond open. He cleared the building and secured the doors that he could.
- 07-06-16 DEO Delebreaux was requested to assist county patrol with a death scene. He provided traffic control while the scene was processed and cleared.
- 07-07-16 DEO Delebreaux was dispatched to locate a suspicious male who possibly had a handgun. The area was checked and the complaint was unfounded.
- 07-11-16 DEO Delebreaux requested to assist county patrol with a major accident at the intersection of CTH X and Glenmore Rd.
- 07-19-16 DEO Delebreaux was called to investigate an incident involving some harassing text messages.
- 07-22-16 and 07-23-16 Both DEOs were present at the Lion's Club picnic periodically. Both DEOs also patrolled the village while monitoring parking issues around the picnic area.
- 07-23-16 Both DEOs responded to a suspicious situation involving a trespassing issue. The issue was later resolved with an arrest.
- 07-24-16 Both DEOs assisted with the Lion's club parade. The parade appeared to be a big success even though it was a little warm. Both DEOs were then present at the picnic periodically after the parade.
- 07-27-16 DEO Dzekute participated in the libraries "Truck Jam" show and tell event. The event was great and there was a great number of kids who came through and got a chance to look at the vehicles at the event.
- 07-27-16 Both DEOs set up the Metro Count on Woodrow to monitor the traffic volume and speed. This data will be used to help understand the traffic trends and help create a plan to assist with the safety of all travel on Woodrow.
- 07-28-16 DEO Dzekute spoke to the Driver's Ed class at the high school.

SCAM report and things to watch out for

- As sad as it is to say, school is just a month away. With that being said, we are going to have a lot more foot and bicycle traffic near the schools. This is just a reminder to make sure that everyone is observant and following traffic laws especially in the areas that kids and students generally travel.
- We are still seeing a lot of scams involving calls claiming to be from the IRS. Do not give out any information to these calls.
- We are seeing scams involving calls stating a person has warrants or they will be picked up by the police for crimes. Don't give out any info to these callers. If you can't remember if you have anything in your past give either DEO a call and we can try to help you through this.
- We are also getting more scams involving calls stating the person has won a prize. As tempting as it might be to claim the "\$2.5 million prize" do not give out any information.

- A possible scam that came through the village actually appeared to be from AARP. The person who received the letter in the mail thought there was something fishy about the letter and turned it over to the DEOs to look at. After looking at the letter we could not confirm that the letter was a scam or if it was legitimate. In the end the person did not give out
- If anyone has a police matter that isn't an emergency but you would like an officer to come out please use the non-emergency number: 920-391-7450. This is the easiest way to either get the Denmark DEOs or if they are not available you will get an available county officer. If you have an issue that does not need immediate police attention you can continue to call the village hall and the message will get to us. Obviously if there is an emergency please call 911.

At the end of this report I have attached two files to help everyone stay safe regarding "Social Engineering." Social Engineering is the art of manipulating people so they give up confidential information.

Social Engineering Red Flags

Human Error. Consequences.**FROM:**

- I don't recognize the sender's email address as someone I **ordinarily communicate with**.
- This email is from **someone outside my organization and it's not related to my job responsibilities**.
- This email was sent from **someone inside the organization** or from a customer, vendor, or partner and is **very unusual or out of character**.
- Is the sender's email address **from a suspicious domain?** (like micorsoft-support.com)
- **I don't know the sender personally** and they **were not vouched for** by someone I trust.
- **I don't have a business relationship** nor any **past communications** with the sender.
- This is an **unexpected or unusual email** with an **embedded hyperlink or an attachment** from someone I hadn't communicated with recently.

**TO:**

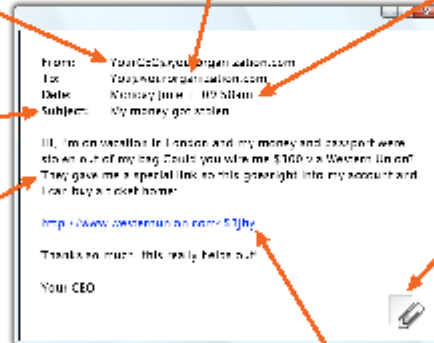
- I was cc'd on an email sent to one or more people, but I **don't personally know** the other people it was sent to.
- I received an email that was also sent to an **unusual mix of people**. For instance, a seemingly random group of people at my organization whose last names start with the same letter, or a whole list of unrelated addresses.

**DATE:**

- Did I receive an email that I normally would get during regular business hours, but it was **sent at an unusual time** like 3 a.m.?

**SUBJECT:**

- Did I get an email with a subject line that is **irrelevant or does not match** the message content?
- Is the email message a reply to something I **never sent or requested?**

**ATTACHMENTS:**

- The sender included an email attachment that I was **not expecting** or that **makes no sense** in relation to the email message. (This sender doesn't ordinarily send me these types of attachment(s).)
- I see an attachment with a **possibly dangerous file type**. The only file type that is **always safe to click on** is a **.TXT** file.

**CONTENT:**

- Is the sender asking me to click on a link or open an attachment to **avoid a negative consequence**, or to **gain something of value?**
- Is the email **out of the ordinary**, or does it have **bad grammar or spelling errors?**
- Is the sender asking me to click a link or open up an attachment that **seems odd or illogical?**
- Do I have an **uncomfortable gut feeling** about the sender's request to open an attachment or click a link?
- Is the email asking me to look at a **compromising or embarrassing picture** of myself or someone I know?

**HYPERLINKS:**

- I hover my mouse over a hyperlink that's displayed in the email message, but the **link to address is for a different website**. (This is a **big red flag**.)
- I received an email that only has **long hyperlinks with no further information** and the rest of the email is completely blank.
- I received an email with a **hyperlink that is a misspelling** of a known web site. For instance, www.bankofamerica.com - the "m" is really two characters - "r" & "n".

Email Social Engineering Red Flags – Part III

Social Engineering is the art of manipulating people so they give up confidential information. Don't fall for their tricks.

Pay close attention to ATTACHMENTS and HYPERLINKS in an email. Here are a few tips to avoid social engineering emails (phishing).

ATTACHMENTS:

- The sender included an email attachment that I was not expecting or that makes no sense in relation to the email message. (This sender doesn't ordinarily send me these types of attachments.)
- I see an attachment with a possibly dangerous file type. The only file type that is always safe to click on is a .TXT file.

HYPERLINKS:

- My mouse hovered over a hyperlink that's displayed in the email message, but the link to address is for a different website. (This is a big red flag.)
- I received an email that only has long hyperlinks with no further information and the rest of the email is completely blank.
- I received an email with a hyperlink that is a misspelling of a known web site. For instance, www.bankofamerica.com – the "m" is really two characters – "r" & "n".
