



VILLAGE OF DENMARK SUMMARY

- Denmark had 84 total incidents in June
- DEO Dzekute and DEO Delebreau handled 57 of the 84 incidents in the village (67.9%)

VILLAGE OF DENMARK PATROL

- DEOs made 15 traffic stops, issued 13 citations, and 13 warnings. There was also 1 parking ticket issued.
- County officers continue to add extra patrol in the village to assist the DEOs

BROWN COUNTY DRUG TASK FORCE IN DENMARK

- Both DEOs continue to monitor the drug tips to keep up to date on any possible drug activity in the village.
- There have been drug tips from some residents that have come in to the DEOs and they will be following up on them

IN DENMARK • The DEOs continue to work with and communicate with the BCSO Investigators about open cases and current investigations.


OWI ARRESTS IN

DENMARK

• There were 0 OWI arrests made during the month of June but enforcement continues throughout the village.

DEO'S IN DENMARK

- The month of June brought us the "Rockin' The Hill" concert. Both DEOs were working for the duration of the event and afterward. The event appeared to be a success and did not generate any extra call volume in the village.
- During the month of June DEOs assisted county patrol with 15 calls outside of the village.





- 06-02-17 DEO Dzekute located some vehicles that had been egged. The owners were contacted and a suspect was also located. The vehicles were cleaned off and the owners did not want a report for the incident.
- 06-04-17 DEO Dzekute attended the graduation ceremony at the high school.
- 06-08-17 DEO Dzekute responded to a physical disturbance. The incident resulted in the arrest of one of the individuals involved.
- 06-10-17 DEO Delebreau had an abandoned vehicle removed from Memorial Park. The vehicle had been called in at different times and it was reported that someone was possibly living in the vehicle in the park.
- 06-10-17 Both DEOs finished preparations around the village for the "Rockin' The Hill" concert.
- 06-10-17 Both DEOs conducted bar checks and made sure the employees were monitoring the patrons to make sure no one was taking alcohol outside the establishments.
- 06-10-17 DEO Delebreau located a suspicious male walking on N. Wall St. The male was stopped and it was determined that he was intoxicated and needed a ride home. A cab was called to take the male home.
- 06-11-17 DEO Dzekute was able to attend the All Saint's picnic. Despite the weather it appeared to be a good turnout and the food was delicious.
- 06-13-17 through 06-15-17 DEO Dzekute attended the SRO Conference put on through FVTC. It was a great conference and there were a lot of good presentations given.
- 06-20-17 DEO Delebreau located a child walking on Depere Rd. The child has special needs and the mother was located shortly after the child was found. No other issues besides the child wandering out to the sidewalk.
- 06-22-17 DEO Dzekute responded to the elementary school for a theft complaint. Most of the items taken had been returned but Mrs. Birdsall asked for assistance in getting the other items returned or paid for.
- 06-22-17 DEO Delebreau assisted with a possibly suicidal party that was outside the village. The party stopped at Mc Donald's and DEO Delebreau transported the party to the hospital for treatment and evaluation.
- 06-24-17 DEO Delebreau was called to assist county officers with a disturbance outside of the village.
- 06-26-17 DEO Dzekute responded to a call for a resident that had left a group home on foot. The resident was located and brought back safely to the group home.
- 06-27-17 DEO Delebreau was able to take a party into custody on an active arrest warrant.
- 06-27-17 DEO Dzekute gave a presentation to a summer school class.
- 06-29-17 DEO Delebreau took a theft report from the high school. A cell phone was taken from someone's belongings.



INFORMATION BULLETIN

- There are also a lot more people out walking, running, and biking with the nice weather. If you are driving please be aware of the non-motorized commuters. Remember that pedestrians have the right of way while in crosswalks and that means marked and unmarked. Please make sure you share the roadways with bicycles, they have the right to be there just like vehicles do. For those of you walking please make sure you are crossing streets at the crosswalks since this is the safest place to cross. If you must cross mid block or in an area where there isn't a crosswalk you are legally allowed to in the state of Wisconsin but we ask that you make sure you are looking both ways for traffic before crossing. The preferred area is always a crosswalk. If you must walk on the road please make sure that you are walking on the left side of the roadway (against the flow of traffic). If you are biking and over the age of 12 please use the roadway as vehicles are classified in Wisconsin as vehicles. Younger riders are still allowed to ride on the sidewalk and should use caution when approaching or passing pedestrians.
- IRS scams are still going around so please be aware of anything you think is a scam. A big thing to remember is that the IRS is going to use the postal service if there is going to be any contact. If you receive a call that you feel is a possible scam **don't** give out any information and report the incident by calling **920-391-7450**
- Just a reminder to keep all vehicles, homes, and outbuildings locked. We may trust our neighbors, but can we always trust the stranger that finds their way into the village. **DON'T** be a "soft target" for criminal activity.
- It is important to remember to call in any type of suspicious activity. With the recent string of thefts we have had some incidents that have not been called in when they happen. The sooner the activity gets called in the sooner we can get officers in the area and hopefully get this problem to stop. The number to call is <u>920-391-7450</u>. If it's an emergency always dial 911.
- The voicemail in the DEO office is now set up. We will be checking the voicemail throughout our shift. If you need an officer to come out please continue to use the non-emergency number listed above or below or 911 for an emergency.
- If there are any drug issues that you notice throughout the village and you would like to report them please call the **Brown County Drug**Task Force tip line: 920-437-DRUG(3784). The tips that come in from the village will get sent and viewed by both DEOs. We can then follow up on the tips.
