Waste Transfer Station

GENERAL FEES

- Loads weighing less than 880 pounds will be charged a minimum fee of \$22.00. A load weighing more than 880 pounds will be charged the Gate Rate per ton.
- 2020 Brown County Waste Transfer Station Gate Rate is **\$50.00 per ton**. Large volume customers willing to contractually commit tonnage for a 5 or 10 year term may be eligible for a lower rate.
- The fee to direct haul waste by Brown County customers to the Outagamie County Landfill will be **\$37.03 per ton** with prior approval.

PAYMENT METHODS

- The Waste Transfer Station **does not accept cash**; customers can pay by credit card, check or by setting up an approved credit account.
- Cards accepted include: Mastercard, Visa & Discover.

TARPED LOADS

- Reminder that all loads coming to the Waste Transfer Station must be tarped.

SAFETY VESTS

- We require safety vests/high visibility clothing to be worn by all persons who exit the vehicle at either Transfer Station.
- Vests may be purchased for a \$5.00 fee.

FROZEN LOADS

- Brown County will initiate a \$25/ frozen box load dig out fee:
 - Account customers - fee will be added to your monthly invoice.
 - All other customers - fee will be due at time of services.

SHINGLES

- Beginning January 1st, 2020, Brown County will no longer accept dirty shingles for recycling. Dirty shingles will be accepted at the Transfer Station at gate rate pricing.
- Clean shingles will still be accepted for recycling at the rate of \$16/ton.

ELECTRONIC TICKETS

- Beginning January 1st, 2020 all account customers must receive Transfer Station tickets electronically rather than paper copy at the scale.

Hazardous Material Recovery Facility

- Non-hazardous and universal waste items will have a **\$0.30/lb** fee in 2020 including batteries, all light bulbs, electronics, light ballasts, adhesives, caulk/glaze/grout/putty, cement/mortar/plaster, latex paint, antifreeze, windshield wiper fluid, cooking oil/grease, and small corded appliances.
- Automotive lead-acid batteries will be charged **\$1.00/unit**.
- Microwaves and fire extinguishers will be charged **\$5.00/unit**.
- Dehumidifiers, miniature refrigerators, small A/C units and small water coolers will be charged **\$15.00/unit**.
