Summary

- ❖ **144** calls for service in the Village of Denmark from **8/1/2023 – 8/31/2023**
- ❖ Brown County Sheriff's Office (BCSO) deputies provide additional enforcement, police services and respond to calls for service when DEOs are not available.

In the Community

- ❖ **PRESCRIPTION DRUG TAKE BACK** - As a reminder, this drop off site is open Monday – Friday during normal Village of Denmark municipal hours.
- ❖ **Coffee with a Cop** – Denmark Officers will be at DeGrand Family Restaurant for Coffee with a Cop the first Tuesday of the month from 8-9 AM. Residents can come in ask questions, voice concerns, and get to know the Village Officers!
- ❖ **Speed Board** – The speed board has been placed on North Wall St just north of Denmark High School for traffic near the schools.
- ❖ **Crossing Guards** – Bill Kane and Lynn Paulson will be back for the 2023-2024 school year as our crossing guards. We are still looking for one additional crossing guard. Interested parties please contact the Denmark Village Hall.
- ❖ **Frogger Event 8/31/23** – **46** drivers correctly yielded to pedestrian crossing the intersection. **16** drivers did not correctly yield to the pedestrian crossing the intersection resulting in a traffic stop. **16** written warnings were issued for Fail to Yield Right-of-Way to pedestrian. **3** total citations were issued for operating without a valid license, operating without insurance, and operating after revocation.
- ❖ **Bar Compliance Checks** – On 8/4/23 the Denmark DEO's along with two other east side DEO's for the Brown County Sheriff's Office did bar compliance checks on establishments in the Village of Denmark, Village of Bellevue, Village of Allouez, and Town of Ledgeview.

Meetings, Associations & Presentations.

- ❖ There will be no court in the Village of Denmark for October.

Traffic / Ordinance Enforcement

- ❖ Officers use **traffic enforcement** as one mean to modify, correct and educate operators on dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
 - ❖ There were **51** traffic contacts initiated and **2** traffic crashes in the Village of Denmark.

- Of those traffic contacts, **27** traffic citations issued, and **51** traffic warnings issued.
 - **0** OWI arrests / citations.
- ❖ **Ordinance citations** are used to enforce the codes that are specific to Denmark. There was **1** ordinance citation(s) issued.

Administrative

- ❖ **Denmark DEO's actively assisting BCSO Investigative with 2 cases.**
- ❖ **Significant Calls for Service:**
- ❖ **Disturbance** – Brown County Sheriff's Office Deputies responded to the Village for a report of an intoxicated male walking up and down the road punching mailboxes and screaming at people.
 - ❖ **Fraud** – A local business was victim of a fraud resulting in approximately \$15,000 in fraudulent purchases made.
 - ❖ **Suspicious Person** – Brown County Deputies responded for a report of three individuals breaking into cars, and it was believed the three suspects were carrying “nerf guns”. The suspects were not located as deputies were rerouted to a high priority call elsewhere in the county.
 - ❖ **Domestic Disturbance** – Deputies were dispatched to a disturbance that resulted in the arrests of two individuals for domestic violence related charges.
 - ❖ **Attempted Burglary** – Village resident reported two suspects attempted entering a garage overnight. Motion sensor security lights activated, and the suspects fled on foot. The suspects were not located. – Reminder to lock all doors to your residence and vehicles overnight.
- ❖ **Chronic Nuisance Properties (CNP)**
- ❖ Currently, there is **1** property deemed a CNP in the Village of Denmark.
 - ❖ DEO's working with Landlord(s)/tenants
- ❖ **Sex Offender Registrants**
- ❖ Currently there are no active Sex Offender Residency Appeals.
 - ❖ Currently **0** Sex Offender (pending) Appeal process for Residency within the Village.
- ❖ **Patrol Vehicles/Equipment**
- ❖ Brown County Sheriff's Office issued new rifles for all patrol vehicles including the Denmark Squads.
 - ❖ DEO Rusk has been working with “Git Lit” to resolve an issue with the emergency lights not working properly on the new squad car.

Joint Efforts

- ❖ **Crime Stoppers**
- ❖ Both DEOs continue to monitor anonymous tips that come in through Green Bay Area Crime Stoppers. These tips are received at Crime Stoppers through phone or online. DEOs are then forwarded these tips for follow-up.

Information Bulletin

❖ Park hours

- Reminder, park hours for the public are from 8:00 a.m. – 10:00 p.m. No person shall be present in the park after hours. Parking ordinances are also enforced within park after hours.

❖ Off-the-road vehicles

- ❖ Reminder, **Village code 208-18** states “No person shall ride or operate, or permit a child to operate, any bicycle, minibike, trail bike, all-terrain vehicle or other vehicle except in areas specially designated for its use” – Other vehicles includes golf carts.

Crime Prevention

❖ House Check Requests

- ❖ Remember, if you're leaving town for a weekend or taking a vacation or traveling –fill out a house check request form; it can be located on the village website. These forms are forwarded to DEOs for documentation, checks, and extra patrol. These checks offer extra supervision over your home and provide DEOs information on who to contact while you are away if needed as well as what to expect for activity/vehicles at your home.

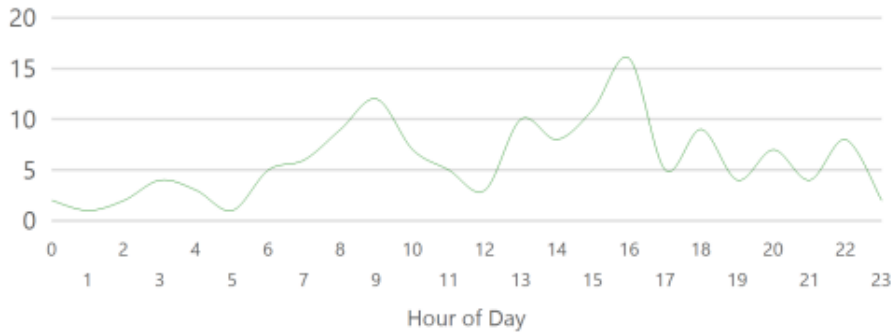

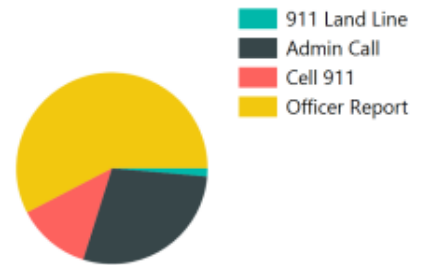
