September 2023

Summary

- ❖ **123** calls for service in the Village of Denmark from **9/1/2023 – 9/30/2023**
- ❖ Brown County Sheriff's Office (BCSO) deputies provide additional enforcement, police services and respond to calls for service when DEOs are not available.

In the Community

- ❖ **PRESCRIPTION DRUG TAKE BACK** - As a reminder, this drop off site is open Monday – Friday during normal Village of Denmark municipal hours.
- ❖ **Coffee with a Cop** – Denmark Officers will be at DeGrand Family Restaurant for Coffee with a Cop the first Tuesday of the month from 8-9 AM. Residents can come in ask questions, voice concerns, and get to know the Village Officers!
- ❖ **Frogger Event 10/4/23** – **60** drivers correctly yielded to pedestrian crossing the intersection. **15** drivers did not correctly yield to the pedestrian crossing the intersection resulting in a traffic stop. **20** written warnings were issued for Fail to Yield Right-of-Way to a pedestrian in a crosswalk. Only **1** citation was issued for operating without a valid license. The regional “Frogger” event is done primarily as an effort to educate drivers on the pedestrian laws in the State of Wisconsin and to improve pedestrian safety through proactive measures.

Meetings, Associations & Presentations.

- ❖ Denmark Municipal Court is scheduled for **November 1, 2023**, at 6:30PM. Denmark Municipal Court is normally scheduled for the first Wednesday of the month at 6:30 PM (subject to change).

Traffic / Ordinance Enforcement

- ❖ Officers use **traffic enforcement** as one mean to modify, correct and educate operators on dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
 - ❖ There were **32** traffic contacts initiated and **4** traffic crashes in the Village of Denmark.
 - Of those traffic contacts, **22** traffic citations issued, and **35** traffic warnings issued.
 - **0 OWI** arrests / citations.
- ❖ **Ordinance citations** are used to enforce the codes that are specific to Denmark. There was **10** ordinance citation(s) issued.

Administrative

- ❖ **Denmark DEO's actively assisting BCSO Investigative with 1 case.**
- ❖ **Significant Calls for Service:**
 - ❖ **Retail Thefts** – A business in the village was having an ongoing issue with a teen stealing liquor. The suspect was identified and cited accordingly.
 - ❖ **Hit and Run to Unattended Vehicle** – BCSO deputies responded for a Hit and Run to an unattended vehicle parked on a village street. Unknown suspect.
 - ❖ **Burglary in Progress** – Brown County Deputies responded to a Burglary in Progress call in the village. This call generated a large police response. This call turned out to be a misunderstanding between the complainant and suspect and all parties were released with no charges.
 - ❖ **Thefts from Vehicle** – Deputies were dispatched to another theft from vehicle in a resident's driveway.
- ❖ **Chronic Nuisance Properties (CNP)**
 - ❖ Currently, there is 1 property deemed a CNP in the Village of Denmark.
 - ❖ DEO's working with Landlord(s)/tenants
- ❖ **Sex Offender Registrants**
 - ❖ Currently there are no active Sex Offender Residency Appeals.
 - ❖ Currently 0 Sex Offender (pending) Appeal process for Residency within the Village.
- ❖ **Patrol Vehicles/Equipment**
 - ❖ Rob from "Git Lit" came up to the Sheriff's Office on 9/28 and resolved the issue with the emergency lights not working properly on the new squad car.

Joint Efforts

- ❖ **Crime Stoppers**
 - ❖ Both DEOs continue to monitor anonymous tips that come in through Green Bay Area Crime Stoppers. These tips are received at Crime Stoppers through phone or online. DEOs are then forwarded these tips for follow-up.

Information Bulletin

- ❖ **Park hours**
 - Reminder, park hours for the public are from 8:00 a.m. – 10:00 p.m. No person shall be present in the park after hours. Parking ordinances are also enforced within park after hours.
- ❖ **9PM Routine**
 - ❖ Due to the large amounts of thefts from vehicles and thefts from garages lately, it is recommended residents implement a 9 PM routine to ensure car doors and residence doors are kept locked, valuables are removed from your vehicles and hidden, exterior lights are left on, and making sure the garage door is

closed. These are all small easy steps everyone can take to help deter criminal activity in our neighborhoods.

❖ **Off-the-road vehicles**

- ❖ Reminder, **Village code 208-18** states “No person shall ride or operate, or permit a child to operate, any bicycle, minibike, trail bike, all-terrain vehicle or other vehicle except in areas specially designated for its use” – Other vehicles includes golf carts,

Crime Prevention

❖ **House Check Requests**

- ❖ Remember, if you're leaving town for a weekend or taking a vacation or traveling –fill out a house check request form; it can be located on the village website. These forms are forwarded to DEOs for documentation, checks, and extra patrol. These checks offer extra supervision over your home and provide DEOs information on who to contact while you are away if needed as well as what to expect for activity/vehicles at your home.

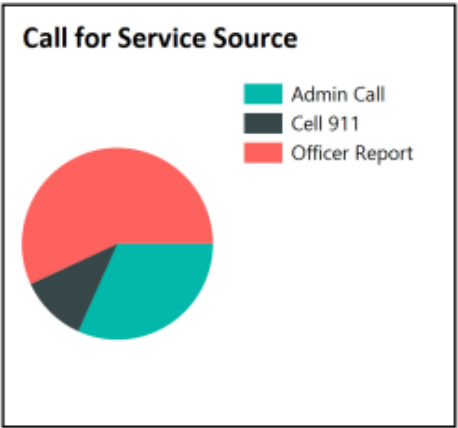
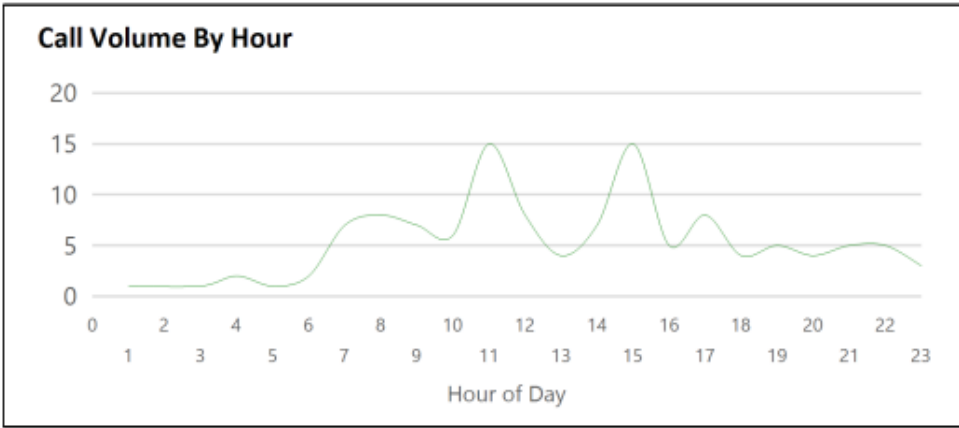
