Summary

- ❖ **118** calls for service in the Village of Denmark from **4/1/2024 – 4/30/2024**
- ❖ Brown County Sheriff's Office (BCSO) deputies provide additional enforcement, police services and respond to calls for service when DEOs are not available.

In the Community

- ❖ **PRESCRIPTION DRUG TAKE BACK** – As a reminder, this drop off site is also open Monday – Friday during normal Village of Denmark municipal hours.
- ❖ **Coffee with a Cop** – Denmark Officers are generally at DeGrand Family Restaurant for Coffee with a Cop the first Tuesday of the month from 8-9 AM. ***The next event has been rescheduled to the second week in June.*** The next Coffee with a Cop event will be **Tuesday June 11, 2024**. Residents can come in to ask questions, voice their concerns, and get to know the Village Officers!

Meetings, Associations & Presentations.

- ❖ Denmark Municipal Court is scheduled for **June 5, 2024**, at 6:30PM. Denmark Municipal Court is normally scheduled for the first Wednesday of the month at 6:30 PM (subject to change).

Traffic / Ordinance Enforcement

- ❖ Officers use **traffic enforcement** as one mean to modify, correct and educate operators on dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
 - There were **17** traffic contacts initiated and **3** traffic crashes in the Village of Denmark.
 - Of those traffic contacts, **11** traffic citations were issued, and **19** traffic warnings were issued.
 - **0 OWI** arrests / citations.
- ❖ **Ordinance citations** are used to enforce the codes that are specific to Denmark. There were **5** ordinance citation(s) issued.

Administrative

- ❖ **Denmark DEO's actively assisting BCSO Investigative with 1 case.**
- ❖ **Significant Calls for Service:**
 - **Criminal Damage to Property** – DEO Rusk responded to a residence in the Village for a disturbance between neighbors following a minor two vehicle car accident. One subject damaged the other's out of frustration following the crash. This call resulted in an ordinance citation for criminal damage to property.
 - **Suspicious vehicle** – DEO's were notified of a Facebook post regarding a child in the Village being chased by a tan SUV. The Facebook post reported that the driver was wearing a ski mask, and their face was hidden. Follow up was conducted for this incident. The child was walked home by a nearby citizen and was safe. Video of the incident was reviewed, and it is unclear what exactly happened. The suspect vehicle was not identified.
 - **Disturbance** – DEO's and additional BCSO Deputies responded to the truck stop area at Kwik Trip for a disturbance call. Two out of state truck drivers got into a verbal altercation and a knife was shown, but not used by one party. Parties were civil when deputies arrived and sent on their way.
 - **Disturbance** – BCSO Deputies responded to a local business for a disturbance that resulted in one individual being arrested for a warrant.
 - **Noise Complaints** – BCSO Deputies responded to a residence in the Village for two separate noise complaints involving loud music at unreasonable hours of the night.
 - **Disturbance** – BCSO Deputies responded to a residence in the village for a physical disturbance. This call involved several intoxicated individuals physically fighting and resulted in one arrest for bail jumping.
 - **Hit and Run Crash** – BCSO Deputies responded to a crash in the Village of a vehicle vs utility pole causing the pole to collapse. When the Deputies arrived, they located an unoccupied damaged vehicle. The driver has been identified.
- ❖ **Chronic Nuisance Properties (CNP)**
 - Currently, there is 1 property deemed a CNP in the Village of Denmark.
 - DEO's working with Landlord(s)/tenants.
- ❖ **Sex Offender Registrants**
 - Currently there are no active Sex Offender Residency Appeals.
 - Currently 0 Sex Offender (pending) Appeal process for Residency within the Village.
- ❖ **Patrol Vehicles/Equipment**
 - The speed board has been placed on Main St near Railroad Ave.

Joint Efforts

- ❖ **Crime Stoppers**
 - Both DEOs continue to monitor anonymous tips that come in through Green Bay Area Crime Stoppers. These tips are received at Crime Stoppers through phone or online. DEOs are then forwarded these tips for follow-up.

Information Bulletin

❖ Park hours

- Reminder, Memorial Park hours for the public are from **8:00 a.m. – 10:00 p.m.** No person shall be present in the park after hours. Parking ordinances are also enforced within the park after hours.

❖ Off-the-road vehicles

- Reminder, **Village code 208-18** states “No person shall ride or operate, or permit a child to operate, any bicycle, minibike, trail bike, all-terrain vehicle or other vehicle except in areas specially designated for its use” – Other vehicles includes golf carts,

❖ House Check Requests

- Remember, if you're leaving town for a weekend or taking a vacation or traveling –fill out a house check request form; it can be located on the village website. These forms are forwarded to DEOs for documentation, checks, and extra patrol. These checks offer extra supervision over your home and provide DEOs information on who to contact while you are away if needed as well as what to expect for activity/vehicles at your home.

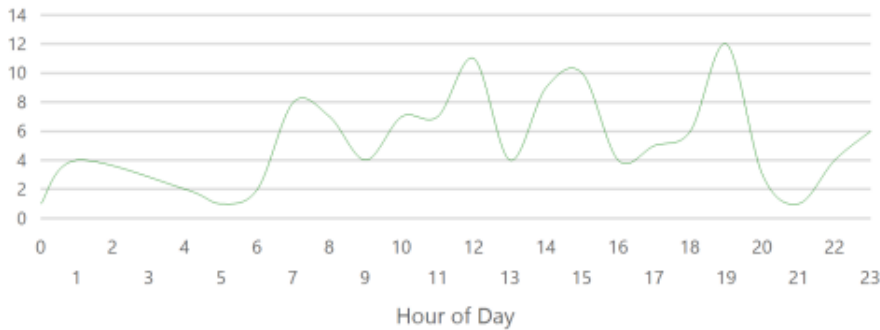

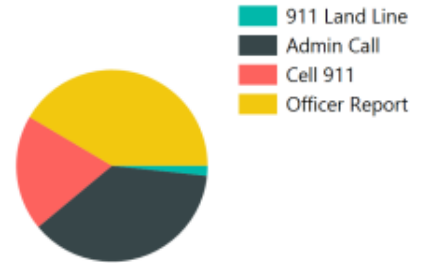
