Summary

- ❖ 102 calls for service in the Village of Denmark from 7/1/2024 7/31/2024
- ❖ Brown County Sheriff's Office (BCSO) deputies provide additional enforcement, police services and respond to calls for service when DEOs are not available.

In the Community

- ❖ PRESCRIPTION DRUG TAKE BACK As a reminder, this drop off site is also open Monday Friday during normal Village of Denmark municipal hours.
- Coffee with a Cop Denmark Officers will be at DeGrand Family Restaurant for Coffee with a Cop generally the first Tuesday of the month from 8-9 AM. The next event will be Tuesday, September 3, 2024. Residents can come in to ask questions, voice their concerns, and get to know the Village Officers!
- ❖ Movie in the Park DEO Rusk assisted in planning a Movie in the Park night on July 11. Residents were treated to a showing of Kung Fu Panda 4.
- ❖ Lions Parade/Picnic DEO's assisted with the parade and utilized the Lions picnic as a community outreach opportunity. Brown County K-9 officer Deputy Berger and his partner, K-9 Dorian, did a demonstration, the Brown County Bearcat armored vehicle and squad cars were present for residents to check out.
- ❖ Tractor Pulls The Denmark Tractor Pulls were successful and there were no issues that came up from a LE standpoint. DEO's will continue to work with the organizers to ensure safety for future events.
- ❖ Citizen Request for 4 Way Stop Sign There have been two separate requests from Village of Denmark residents to make the intersection of Woodrow St and Oak St a 4-way stop to control speeding issues on Woodrow St particularly at Salm Partners shift changes. The speed board findings are included with this report.

Meetings, Associations & Presentations.

❖ Denmark Municipal Court is scheduled for **September 4, 2024,** at **6:30PM**. Denmark Municipal Court is normally scheduled for the first Wednesday of the month at 6:30 PM (subject to change).

Traffic / Ordinance Enforcement

- Officers use traffic enforcement as one mean to modify, correct and educate operators on dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
 - There were 9 traffic contacts initiated and 2 traffic crashes in the Village of Denmark.
 - Of those traffic contacts, 5 traffic citations were issued, and 15 traffic warnings were issued.

- 0 OWI arrests / citations.
- Ordinance citations are used to enforce the codes that are specific to Denmark. There were 1 ordinance citation(s) issued.

Administrative

- **❖** Denmark DEO's actively assisting BCSO Investigative with 1 case.
- Significant Calls for Service:
 - Theft DEO Rusk responded to an apartment complex in the Village for a theft of mail package containing an Apple Watch. Follow up is still being completed.
 - Harassment DEO Rusk responded to a harassment complaint regarding harassing/vulgar voicemail messages. This call resulted in a citation for unlawful use of a telephone.
 - Burglary DEO Rusk handled a burglary complaint at an apartment complex in the Village. Many valuable items were taken from the victim's apartment. This incident is still being investigated.
 - Auto Theft BCSO Deputies responded to the Village for a report of a vehicle theft. The vehicle was located prior to being listed as stolen. The driver was arrested for a warrant, but the victim did not wish to press further charges for the stolen vehicle.
 - Theft DEO Rusk handled a theft call where the victim had their cellphone taken from their locker at work.
 This incident resulted in the cellphone being recovered, a citation being issued, DEO Pigeon arrested the suspect for a warrant.
 - Accident DEO Pigeon responded to the Denmark Post Office for an accident report of a vehicle that struck the building. This accident caused minimal damage to the building.
 - Fraud DEO Pigeon handled a fraud complaint. The victim was scammed while attempting to purchase a tractor online.

Chronic Nuisance Properties (CNP)

- Currently, there is 1 property deemed a CNP in the Village of Denmark. There is a second residence being
 investigated as another chronic nuisance.
- DEO's working with Landlord(s)/tenants.

Sex Offender Registrants

- Currently there are no active Sex Offender Residency Appeals.
- Currently O Sex Offender (pending) Appeal process for Residency within the Village.

❖ Patrol Vehicles/Equipment

- The speed board has been placed on Woodrow St and Oak St due to speeding complaints in the area.
- The white Durango squad lights continued having issues of intermittently shutting off and not coming back on. A representative from Whelen came to the Sheriff's Office and replaced the circuit board for the lights and they seem to be working at this time.
- The gray Durango has been having mechanical issues causing it to stall out and not start. The fuel pump has been replaced, and an exposed wire has been repaired but the issue has not been resolved. The BCSO mechanic is looking into the issue further.

- Both DEOs continue to monitor anonymous tips that come in through Green Bay Area Crime Stoppers.
 These tips are received at Crime Stoppers through phone or online. DEOs are then forwarded these tips for follow-up.


❖ House Check Requests


