- Brown County Sheriff's Office (BCSO) deputies provide additional enforcement, police services and respond to calls for service when DEOs are not available.

In the Community

- PRESCRIPTION DRUG TAKE BACK As a reminder, this drop off site is open Monday Friday during normal Village of Denmark municipal hours.
- Coffee with a Cop −The next event will be Thursday, December 11, 2024. Coffee with a Cop has been relocated to the new Community Center (formerly the Senior Center) at 141 Highridge Ave.

⊕ Denmark Municipal Court is scheduled for January 8, 2024 at 6:30PM. Denmark Municipal Court is normally scheduled for the first Wednesday of the month at 6:30 PM (changed due to New Years Holiday)

Traffic / Ordinance Enforcement

- Officers use **traffic enforcement** as one means to modify, correct and educate operators on dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
 - There were 5 traffic contacts initiated and 2 traffic crashes in the Village of Denmark.
 - Of those traffic contacts, 1 traffic citation was issued, and 4 traffic warnings were issued.
 - OWI arrests / citations.
- **Ordinance citations** are used to enforce the codes that are specific to Denmark. There were **8** ordinance <u>citations</u> issued. With three potential underage citations requiring follow-up.

Administrative

Denmark DEO's actively assist BCSO Investigative Division with investigations in the Village.

Significant Calls for Service:

- Disturbance BCSO Deputies & Investigators responded to a residence in the Village for a male vs female disturbance that resulted in an arrest and an ICE HOLD
 - Domestic Disturbance BCSO Investigators and DEO Rusk took a report of multiple different domestic violence disturbances involving the same two individuals in the Village. (More Follow up required)
 - Disturbance at Family Dollar BCSO deputies responded to Family Dollar for a physical disturbance at Family Dollar. This resulted in one of the parties being issued a citation for Disorderly Conduct and released.
 - Theft- DEO Pigeon responded took a report for theft of money. The suspect later made threats via phone to harm Deputies with firearms and high-risk traffic stop was conducted. Criminal Charges were referred against suspect.
 - Accident w/Injury BCSO Deputies responded to the area of I-43 and STH 96 for vehicle vs pedestrian crash. As a result of the crash the pedestrian was pronounced deceased.

o Currently, there are 0 properties deemed a CNP in the Village of Denmark. There is a second residence being investigated as another chronic nuisance. DEO's are actively working with Landlord(s)/tenants.

⊕ Sex Offender Registrants

Currently 1 Sex Offender (pending) Appeal process for Residency within the Village.

- o The speed board is still located at Woodrow St and Oak St due to speeding complaints in the area.
- o Potential new squad car to replace the dark gray Dodge Durango.

Joint Efforts

⊕ Crime Stoppers

- o Both DEOs continue to monitor anonymous tips that come in through Green Bay Area Crime Stoppers. These tips are received at Crime Stoppers through phone or online. DEOs are then forwarded these tips for follow-up.

Information Bulletin

- Park hours Reminder, Memorial Park hours for the public are from 8:00 a.m. 10:00 p.m. No person shall be present in the park after hours. Parking ordinances are also enforced within the park after hours.
- **Nighttime Parking Prohibited** Village Code 289-5(B) states: (1) No person shall park any vehicle between 2:00 a.m. and 6:00 a.m. from

November 1 to April 1 on any Village Street. (2) No person shall park any vehicle between 3:00 a.m. and 5:00 a.m. without a permit from the Village on the Village of Denmark Central Business District Parking Lot.

Off-the-road vehicles ○ Reminder, Village code 208-18 states "No person shall ride or operate, or permit a child to operate, any bicycle, minibike, trail bike, all-terrain vehicle or other vehicle except in areas specially designated for its use" – Other vehicles include golf carts.

Crime Prevention

Remember, if you're leaving town for a weekend or taking a vacation or traveling –fill out a house check request form; it can be located on the village website. These forms are forwarded to DEOs for documentation, checks, and extra patrol. These checks offer extra supervision over your home and provide DEOs information on who to contact while you are away if needed as well as what to expect for activity/vehicles at your home.




