Summary

- Brown County Sheriff's Office (BCSO) deputies provide additional enforcement, police services and respond to calls for service when DEOs are not available.

In the Community

- PRESCRIPTION DRUG TAKE BACK As a reminder, this drop off site is open Monday Friday during normal Village of Denmark municipal hours.
- Coffee with a Cop −The next event will be Thursday, February 20, 2025. Coffee with a Cop has been relocated to the new Community Center (formerly the Senior Center) at 141 Highridge Ave in Village of Denmark Residents can come in to ask questions, voice their concerns, and get to know the Village Officers!
 - → Denmark DEO's Rusk and Pigeon both attended 2025 WA Cop Community Policing Conference in LaCrosse, Wisconsin.
 - Bar Checks- Anonymous tip regarding a male party under the legal drinking age of 21 at a bar within the Village. DEO's intend on monitoring this individual and addressing the issue with bar staff

⊕ Denmark Municipal Court is scheduled for **March 5, 2025**, Denmark Municipal Court is normally scheduled for the first Wednesday of the month at 6:30 PM.

Traffic / Ordinance Enforcement

- Officers use **traffic enforcement** as one means to modify, correct and educate operators on dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
 - There were 22 traffic <u>contacts</u> initiated and 3 traffic <u>crashes</u> in the Village of Denmark.
 - ☐ Of those traffic contacts, 9 traffic citations were issued, and 33 traffic warnings were issued.
 - OWI arrests / citations.
- Ordinance citations are used to enforce the codes that are specific to Denmark. There were 21 ordinance citations issued. 20 night-time parking citations were issued.

Administrative

Denmark DEO's actively assist BCSO Investigative Division with investigations in the Village.

Significant Calls for Service:

- <u>Disturbance @Denmark Middle Scho</u>ol. (SRO Gawlik) Responded to a juvenile fight involving a juvenile male being found unconscious. Resulted in charges referred to Juvenile Intake
- Theft / Stolen Plates. (DEO Pigeon was able to locate the plates on a suspect vehicle utilizing Flock. GBPD later located the suspect vehicle and transported the male to Brown County Jail on unrelated charges. DEO Pigeon met with a suspect at Brown County Jail and obtained full confession to stolen plates. Plates returned to the owner and citations issued.
- Disturbance / Theft- DEO Pigeon and BCSO Deputies responded to the area of Kwik Trip for active disturbance involving two individuals test driving a vehicle in the City of Green Bay before refusing to return to owner, while the owner of the vehicle was in the backseat. Vehicle was stopped on a high risk stop in the Village of Denmark and returned to rightful owner.
- Suspicious Situation / Trespassing- DEO Rusk is working on identifying an individual who is loitering in a no parking area outside a local gas station. When asked by staff what he is doing he indicated he is using illegal drugs. DEO Rusk is attempting to ID male and issue a no trespass.
- Harassment at Family Dollar BCSO Deputies and Deo's working ongoing harassment between exemployee and current manager at Family Dollar in the Village of Denmark.
- <u>OWI-Causing Injury</u>- BCSO Deputies responded to vehicle vs pedestrian involving two family members. The incident occurred outside Denmark Saloon. Male was cited for OWI 1st causing injury. It should be noted Denmark Saloon staff denied knowledge of any disturbance.
- Internet Crimes- Denmark DEO's assisted Brown County Investigative Team with an Internet Crimes Against Children (ICAC), search warrant at a residence within the Village. This warrant resulted in criminal charges and an arrest.

OTHER VILLAGE NOTES

- **†** Chronic Nuisance Properties (CNP)
 - o Currently, there are 0 properties deemed a CNP in the Village of Denmark. There is a second residence being investigated as another chronic nuisance. DEO's are actively working with Landlord(s)/tenants.

☆ Sex Offender Registrants

Currently 1 Sex Offender (pending) Appeal process for Residency within the Village.

- o Speed board is still located at Woodrow St and Oak St due to speeding complaints in the area.
- New Dodge Durango ordered (unknown arrival date)
 - o Martin Security new Camera System installed at Denmark Village Hall and Denmark Memorial Park
 - DEO Pigeon squad requires a new catalytic converter replacement. Will schedule Gandrud and replacement will be covered under warranty.

- o DEOs continue to monitor anonymous tips that come in through Green Bay Area Crime Stoppers. These tips are received at Crime Stoppers through phone or online. DEOs are then forwarded these tips for follow-up.

Information Bulletin

- Park hours-Reminder, Memorial Park hours for the public are from 8:00 a.m. − 10:00 p.m. No person shall be present in the park after hours. Parking ordinances are also enforced within the park after hours.
- ₱ Nighttime Parking Prohibited- Village Code 289-5(B) states: (1) No person shall park any vehicle between 2:00 a.m. and 6:00 a.m. from

November 1 to April 1 on any Village Street. (2) No person shall park any vehicle between 3:00 a.m. and 5:00 a.m. without a permit from the Village on the Village of Denmark Central Business District Parking Lot.

[⊕] Off-the-road vehicles- Reminder, Village code 208-18 states "No person shall ride or operate, or permit a child to operate, any bicycle, minibike, trail bike, all-terrain vehicle or other vehicle except in areas specially designated for its use" – Other vehicles include golf carts.

Crime Prevention

Remember, if you're leaving town for a weekend or taking a vacation or traveling –fill out a house check request form; it can be located on the village website. These forms are forwarded to DEOs for documentation, checks, and extra patrol. These checks offer extra supervision over your home and provide DEOs information on who to contact while you are away if needed as well as what to expect for activity/vehicles at your home.




