To seek a variance from the requirements of Section(s) _____ of Chapter 265: Subdivision of Land Ordinance.

Variances:Granting of Variance:

As per Section 265-130.A of the Subdivision of Land Ordinance, a Variance shall not be granted until all of the following conditions have been met:

- (1) The granting of the variance will not be detrimental to the public safety, health, or welfare, or injurious to other property or improvements in the neighborhood in which the property is located.
- (2) The conditions upon which the request for a variance is based are unique to the property for which the variance is sought and are not applicable generally to other property.
- (3) Because of the particular physical surroundings, shape, or topographical conditions of the specific property involved, a particular hardship to the owner would result, as distinguished from a mere inconvenience, if the strict letter of the regulations were carried out.
- (4) The variance will not in any manner vary the provisions of other Village ordinances or the Official Map.

Absence of Detriment:

The Applicant / Agent shall explain how the proposed land division, lot line adjustment, lot combine, or other action regulated under the Village of Denmark Subdivision of Land Ordinance will not be detrimental to the public safety, health, or welfare, or injurious to other property or improvements in the neighborhood in which the property is located:
