ORDINANCE NO. 2005-01
Ordinance to Appoint Alternate Members
For the Board of Review

SECTION 1 - PURPOSE

This ordinance is entitled the Town of Sturgeon Bay Ordinance to Appoint Alternate Members for Board of Review. The purpose of this ordinance is to provide, upon lawful removal of named members, alternate persons to serve as replacements to the Board of Review for the Town of Sturgeon Bay.

SECTION 2 - AUTHORITY

The town board of the Town of Sturgeon Bay has the specific authority under ss. 70.47(6m)(c) and 70.47.(1), Wis. Stats., to remove members from and to appoint alternate members to the Board of Review for the Town of Sturgeon Bay.

SECTION 3 - ADOPTION OF AN ORDINANCE

The town board of the Town of Sturgeon Bay, Door County, Wisconsin, by this ordinance, adopted on proper notice, with a quorum and by a roll call vote of the town board present and voting, provides for the removal of members of the Board of Review for the Town of Sturgeon Bay and the appointment of alternate members.

SECTION 4 - MANNER OF APPOINTMENT

The town board of the Town of Sturgeon Bay, Door County, Wisconsin, by this ordinance, establishes and shall maintain a public list of names and persons eligible and appointed by the town board to serve as alternate members of the board of review. The list shall be arranged and maintained by the town clerk in a priority order of probable and likely service as an alternate. The town clerk shall notify any named member who has been lawfully removed under s.60.47 (6m) (a) or (b) and shall notify the alternate person of his or her appointment to replace a named member of the board of review. The alternate, once noticed, if he or she approves the appointment, and if he or she would not violate s.19.59, Wis. Stats., shall then take the oath of office and act as a member of the board of review under s.60.47 (6m)(c).

SECTION 5 - APPOINTMENTS

The following electors of the Town of Sturgeon Bay are named as alternates in the order indicated to serve as board of review members.

Alternate 2: Mary Thachac
Alternate 3: Harry Porter - Added 2013
Alternate 4: Lynne Gustafson - Added 2018


SECTION 6 – EFFECTIVE DATE

This ordinance is effective on publication or posting.


