You should have received a reminder notice by now from the Dane County Treasurer. If you haven't and need to look up the amount of what you owe, you can log onto Access Dane at <a href="accessdane.danecounty.gov">accessdane.danecounty.gov</a> website and look up your tax information by entering your address. There is also a link on this site for making your payment online. If you do not have access to a computer, feel free to contact the office and we will assist you with that information. If payment is not made by the due date, interest will be accrued on the full tax amount due.

Bids for this years chip seal were received in June. Fahrner Asphalt Paving was awarded the project this year. Roads included in this years project are Schumacher Rd, from County Hwy V to Easy St. Daley Rd, from County Hwy I to Hickory Ln. Also, residential area of Vienna Drive, including the connected streets of Locust, Aspen, and Beech Ct. This part of the chip seal will use a finer rock to seal and contractor will sweep excess material.

# Town of Vienna Board Minutes June 9, 2025

The regular town board meeting was called to order on Monday, June 9, 2025, at 7:00PM by Chair Jerry Marx. Supervisors Amanda Nickel, Dakota Cable, Sherri Meinholz, Gary Endres and Clerk Kathy Clark were present. Also present was residents Nancy Caldwell and Dave Lynch. Supervisor Dakota Cable was excused.

Pledge of Allegiance was recited.

**Public Comment:** Dave Lynch noted that the newsletter referenced discussion on the proposed commercial area referenced in the comprehensive plan. Lynch thought there would be more discussion at this meeting. Clark explained that would be at the next Plan Commission meeting which was cancelled this month. Clark stated that the planned area is located along Patton Rd. and Highway V with ATC on one side and Madison Sand & Gravel (and E80) on the other. Lynch expressed concern on potential increase to traffic on Patton Road. Lynch's property is located at the intersection of County Hwy V and Patton Road.

**Approval of Minutes:** Motion by Endres, second by Nickel to approve the minutes for May 19, Town

Board meeting. Motion carried (4-0).

**Discussion and possible action on Approval of 2025 Chip Seal Bids:** Clark presented bids submitted on Friday, June 6<sup>th</sup> at 10AM by Scott Construction and Fahrner Asphalt. The 2025 lower bid was submitted by Fahrner Asphalt with a \$10,000 difference in total costs. Endres asked why the different rock size is used. Clark explained that the 3/8" rock is for rural roads and the 1/4" rock is used in the residential area. Both bids used the same material and size we required in the bid. Motion by Endres, second by Meinholz to approve and award the 2025 Chip Seal bid to Fahrner Asphalt. Motion carried (4-0)

# Dave Lynch arrived late for public input. Town Chair moved to allow public input at this time.

**Discussion and possible action on New Loan for Road Improvement:** Clark explained that the information from DMB Bank was not received in time for this meeting. Once the rate and totals are submitted with a 5-year payment plan, the board will decide. No action was taken.

**Discussion and possible action on New Wheeler Park Donation Bank account:** Clark informed the members that the Auditors suggested opening a separate savings account for Wheeler Park donations towards improvements planned this summer. A committee has been formed to work with the town on gathering some historical notes for placing on the new sign. The first meeting should be occurring this month. The bank needs recorded minutes approving this new account and designated funds. Motion by Meinholz, second by Endres to approve opening a new savings account at DMB for Wheeler Park donations. Motion carried (4-0)

#### Town of Vienna Board Minutes June 23, 2025

The regular town board meeting was called to order on Monday, June 23, 2025, at 7:00PM by Chair Jerry Marx. Supervisors Amanda Nickel, Dakota Cable, Sherri Meinholz, Gary Endres and Clerk Kathy Clark were present. Also present was US Cell Representative Joshua Watson (via ZOOM) and resident Nancy Caldwell.

Pledge of Allegiance was recited.

**Public Comment:** None

**Approval of Minutes:** Motion by Meinholz, second by Nickel to approve the minutes for June 9, Town Board meeting. Motion carried (4-0).

Supervisor Endres arrived late from another meeting.

Discussion and possible action on Cell Tower Design submitted for Review: Clark introduced Johs Watson with US Cellular to discuss the possibility of setting up a cell tower near our UD 1 Lift Station. A certified survey map (CSM) was provided of the land and lift station owned by the town located on River Road. Watson explained that the location was really needed to service this area of Dane County due to large growth. A new tower was recently approved for a location on Cuba Valley, in the Town of Vienna. While working on the Cuba Valley project, the US Cellular Engineers encourage Watson to search for another location to pursue another

tower going up. The Cuba Vally one would not be enough to serve the area in the future and the process takes close to a year to review. Watson explained the stages in which this would incur. The first being stage after a draft design is presented, is signing an agreement, "Right of Entry and Testing" for the River Road site. This would allow further research on the site, such as soil testing and land use rights/easements needed. Clark asked the town engineer to review the draft prior to the meeting. The review provided a revised drawing relocating the fence. Once this is received, US Cellular will provide another design with more detail and testing results for further analysis of site location. Discussion of fees and payments followed. Motion by Cable, second by Endres to proceed with signing the of agreement "Right of Entry and Testing" to allow further research and a survey to be performed and presented based on findings. Motion carried (5-0)

**Discussion and possible action on Approval of 2025-2026 Annual Liquor license Renewals:** Clark presented a list of annual liquor license applications for businesses in the town. The list consists of "off premise" sales such as quick marts that sell gas, cigarettes and liquor. Others are on premise, such as hotels or clubs. Also, individual Operator licenses were renewed. Motion by Nickel, second by Meinholz to approve the 2025-2026 Annual liquor licenses as presented. Motion carried (5-0)

**Discussion and possible action on New Loan for Road Improvement:** Clark explained that the information received from DMB Bank as presented. The options were to borrow \$300K or \$350 with a government rate 5.09%. Discussion followed. Motion by Endres, second by \$350K for road improvements for a 5-year period with additional payments made as state funds for roads are received. Motion carried (5-0)

**Operator's License:** One application was submitted by Travel Mart All Stop for review. Motion by Endres, second by Cable to approve the operator license application for Dylan Walters. Motion carried (5-0)
