2022 Road Projects

This year, the Town of Vienna is soliciting road bids for WIBU, from County Road DM to Meek Road (County Line Rd). Kelley Lane and Madigan Road also have work scheduled for this summer. Bids are due to the town by May 26th at 10AM for opening. Bids will be reviewed at the town board meeting June 6th for approval. Also underway are bids for chip sealing roads. Several roads are listed for bid purposes but depending on how the costs come in, the final selection will be made based on budget restraints. Dane County and WisDot are working on plans to reconstruct County Road V, from State Hwy 113 to County Hwy I (where Exxon is located). This will include widening intersection and paved shoulders at Madigan Rd, Schumacher Rd, Patton Rd, Norway Grove Rd and County Highway I, just outside Town Hall.

Manure Hauling

It has been brought to the town board's attention that trucks hauling manure prefer to park on a road incline to create pressure in the tank. Usually this is located near or on a blind hill on the road. To avoid any last reacting drivers to swerve, the town is recommending signs be put on both sides of the truck warning approaching vehicles. If you or your contractor hauler do not have signs, the town will gladly provide them upon request. This is most important when it's getting dark and harder to see on the road.

Trash Recycling Bins in Road

Since the pick up day has changed, it seems like our pick up service has improved. It is important to have your bins out the night before or by 6:00am in the morning. I was informed that the drivers start at 5:30am and can be in our area as early as 6:00am to start their route. Please remember to keep your bins in your driveway for pick up and not in the street.

Bulk Waste Event a Success

On Saturday, May 21st from 8am-12pm the town had a dumpster available for disposing bulk items such as furniture, rolled carpet (4' length maximum) mattresses, couches, cabinets and construction materials that are difficult to discard properly. Thank you for participating.

Roadside Mowing

Roadside ditch mowing will begin in early June. The first round should be completed by early July. The second round will include mowing the ditches out to the fence lines. A final round will be done in the fall, weather permitting.

Town Comprehensive Plan

The town is starting to review the current comprehensive plan that was adopted in 2012. Since that time, land zoning references have changed at Dane County along with surrounding municipality plans for future development. Adopt a Road Program

The Town of Vienna participates in the Adopta-Road program where a business, a club or a resident signs an agreement with the town to adopt a section of the road and become responsible for cleaning up both sides of the road every spring and fall. The town provides safety vests, trash bags, safety road signs and safety glasses. A sign is placed with the name of the participant on the section of road adopted in recognition of your time and contribution to this program. The board reviewed the new language and had questions about it. Endres questioned whether the 20% maintenance cost is still applicable as other property owners joined the district. Several other questions were raised and it was agreed that this needed more information on the new proposed language.
