2025-2026 TAX COLLECTIONS: The first installment of your taxes (which includes special assessments and/or charges) is due **January 31, 2026.** Please include the bottom portion of your tax bill with your payment. If you have escrow funds, please remember to endorse checks which are payable to the homeowner and the Town of Vienna prior to sending payment. If you choose to pay on the installment plan, the **SECOND INSTALLMENT IS DUE BY JULY 31, 2026, AND GOES TO THE DANE COUNTY TREASURER PO BOX 1299 MADISON, WI 53701-1299**

Tax Payments: Please make checks payable to: **TOWN OF VIENNA.** Please make sure your check is signed and lists the bill number or parcel number. **If you would like a receipt, you MUST provide a self-address stamped envelope.**

- * Tax payments will be accepted during regular office hours (Monday – Friday 8:00am – 4:00pm)
- * **Note:** Town Hall will be **CLOSED** on December 24, December 25, December 31 and January 1st.
- * For your convenience a secure drop-box is available in the vestibule which is open 24 hours a day.

For those concerned about deadlines, please mail your payment at least a week in advance.

If you would like to verify if your tax payment was received, you may check the **ACCESS DANE** website **<https://accessdane.danecounty.gov/>**. Payments and parcel information are available to all Dane County residents. Please check the website for up-to-date information.

SEWER CHARGES (UD2): If you live in utility district 2 you will notice an increase in the sewer charge on your tax bill. This is directly related to Madison Metropolitan Sewer District increasing their fee to us. In order to cover their fee increase we are increasing the amount charged to our residents. Please let us know if you have any questions.

LOCAL LEVY CHANGE: Taxes for Fire and EMS Services are now included with the Town of Vienna levy on your 2025 tax bill. You will notice a \$0.00 amount for your respective Fire and EMS Districts, and the Town of Vienna's amounts have increased. This is a change at the County level and will continue in the future. **Please contact us if you have any questions**
