# SIXTH AMENDMENT TO ORDINANCE 2017-1 DESIGNATING ALL-TERRAIN VEHICLE AND UTILITY-TERRAIN VEHICLE ROUTES AND REGULATING THE OPERATION OF ALL TERRAIN VEHICLES AND UTILITY TERRAIN VEHICLES IN THE TOWN OF LAFAYETTE, CHIPPEWA COUNTY, WISCONSIN

WHEREAS, the Town enacted Ordinance 2017-01 (the "Ordinance") on December 18, 2017, and amended on March 19, 2019, August 19, 2019, September 16, 2019, August 1, 2022 and to designate ATV routes and regulate operation of ATVs and UTVs in the Town of Lafayette.

**NOW, THEREFORE**, as an amendment to the Ordinance, the Town Board enacts this Sixth Amendment to the Ordinance (the "Sixth Amendment"), as follows:

- 1. Section J of the Ordinance is amended to add the following All-Terrain Routes:
  - All Town of Lafayette town roads as routes, except the request from petitioners that 51st and 52nd Ave west of Stillson School remain closed.
- 2. Except as amended by this Sixth Amendment, all other terms and conditions of the Ordinance shall remain unchanged and in full force and effect. All capitalized terms used in this Sixth Amendment which are not otherwise defined herein shall have the meanings ascribed to such terms in the Ordinance.
