FIFTH AMENDMENT TO ORDINANCE 2017-01**

**FIFTH AMENDMENT TO ORDINANCE 2017-1 DESIGNATING ALL-TERRAIN VEHICLE  
AND UTILITY-TERRAIN VEHICLE ROUTES AND REGULATING THE OPERATION OF  
ALL TERRAIN VEHICLES AND UTILITY TERRAIN VEHICLES IN THE TOWN OF  
LAFAYETTE, CHIPPEWA COUNTY, WISCONSIN**

**WHEREAS**, the Town enacted Ordinance 2017-01 (the "Ordinance") on December 18, 2017, and amended on March 19, 2019, and August 19, 2019, to designate ATV routes and regulate operation of ATVs and UTVs in the Town of Lafayette.

**NOW, THEREFORE**, as an amendment to the Ordinance, the Town Board enacts this Fifth Amendment to the Ordinance (the "Fifth Amendment"), as follows:

1. Section J of the Ordinance is amended to add the following to All-Terrain Routes:

- **New Roads for Ordinance 70th Avenue and North Lake Roads.**
- 70th Avenue from Intersection of County Road K to 178<sup>th</sup> Street Intersection
- 178<sup>th</sup> Street from Intersection of 70<sup>th</sup> Avenue to 180<sup>th</sup> Street
- 75<sup>th</sup> Avenue (Bay Road) from Intersection 178<sup>th</sup> Street to 185<sup>th</sup> Street Intersection
- 180<sup>th</sup> Street from 178<sup>th</sup> Street to 75<sup>th</sup> Avenue (Bay Road) Intersection
- 185<sup>th</sup> Street from Intersection of 70<sup>th</sup> Avenue to 77<sup>th</sup> Avenue Intersection
- 74<sup>th</sup> Avenue from Intersection of 185<sup>th</sup> St to 74<sup>th</sup> Avenue Dead End
- 77<sup>th</sup> Avenue from Intersection of 185<sup>th</sup> Street to 76<sup>th</sup> Avenue Intersection
- 183<sup>rd</sup> Street from Intersection 77<sup>th</sup> Avenue to 79<sup>th</sup> Avenue
- 79<sup>th</sup> Avenue from 183<sup>rd</sup> Street to 78<sup>th</sup> Avenue
- 185<sup>th</sup> Street from Intersection of 78<sup>th</sup> Avenue to 183<sup>rd</sup> Street Intersection
- 78<sup>th</sup> Avenue from 79<sup>th</sup> Avenue to 77<sup>th</sup> Avenue Intersection
- 76<sup>th</sup> Avenue from Intersection of 77<sup>th</sup> Avenue to 75<sup>th</sup> Avenue Intersection
- 189<sup>th</sup> Street from Intersection of 76<sup>th</sup> Avenue to 75<sup>th</sup> Avenue Intersection
- 75<sup>th</sup> Avenue from Intersection of 76<sup>th</sup> Avenue to 74<sup>th</sup> Avenue Intersection
- 74<sup>th</sup> Avenue from Intersection of 192<sup>nd</sup> Street to 70<sup>th</sup> Avenue Intersection
- 72<sup>nd</sup> Avenue from Intersection of 76<sup>th</sup> Avenue to 192<sup>nd</sup> Street Intersection
- 190<sup>th</sup> Street from Intersection of 72<sup>nd</sup> Avenue to 71<sup>st</sup> Avenue Intersection
- 71<sup>st</sup> Avenue from Intersection of 190<sup>th</sup> Street to 192<sup>nd</sup> Street Intersection
- **New Roads for Ordinance North of 50<sup>th</sup> Avenue behind old Stillson Elementary.**
- 50<sup>th</sup> Avenue from Intersection 176<sup>th</sup> Street to County Road J Intersection
- 175<sup>th</sup> Street from Intersection of 50<sup>th</sup> Avenue to 174<sup>th</sup> Street Intersection
- 174<sup>th</sup> Street from 175<sup>th</sup> Street Intersection to 53<sup>rd</sup> Avenue Intersection
- 174<sup>th</sup> Street from Intersection of 53<sup>rd</sup> Avenue to 54<sup>th</sup> Avenue Intersection
- 54<sup>th</sup> Avenue from Intersection of County Road J to 174<sup>th</sup> Street Intersection
- 54<sup>th</sup> Avenue from 174<sup>th</sup> Street Intersection to 176<sup>th</sup> Street Intersection
- 175<sup>th</sup> Street from 54<sup>th</sup> Avenue Intersection to 53<sup>rd</sup> Avenue Intersection

● **New Roads for Ordinance South of 50<sup>th</sup> Avenue Irwin's Subdivision.**

- 50<sup>th</sup> Avenue from Intersection 176<sup>th</sup> Street to County Road J Intersection
- 174<sup>th</sup> Street from 50<sup>th</sup> Avenue Intersection to 48<sup>th</sup> Avenue
- 49<sup>th</sup> Avenue from Intersection of 174<sup>th</sup> Street to 49<sup>th</sup> Avenue Dead End
- 49<sup>th</sup> Avenue from Intersection of 174<sup>th</sup> Street to 177<sup>th</sup> Street Intersection
- 48<sup>th</sup> Avenue from Intersection of 174<sup>th</sup> Street to 176<sup>th</sup> Street
- 176<sup>th</sup> Street from Intersection of 49<sup>th</sup> Avenue to 48<sup>th</sup> Avenue
- 177<sup>th</sup> Street from South Dead End to Behind Sand Bar
- 177<sup>th</sup> Street from Intersection of 177<sup>th</sup> Street to 177<sup>th</sup> Street Dead End


● **New Roads for Ordinance Southeast of 50<sup>th</sup> Avenue**

- 50<sup>th</sup> Avenue from Intersection of County Road J to 160<sup>th</sup> Street Intersection
- 160<sup>th</sup> Street from Intersection of 50<sup>th</sup> Avenue to 20<sup>th</sup> Avenue Intersection
- 40<sup>th</sup> Avenue from Intersection of 160<sup>th</sup> Street to County Road J Intersection
- 35<sup>th</sup> Avenue from Intersection of 160<sup>th</sup> Street to 35<sup>th</sup> Avenue Dead End
- 172<sup>nd</sup> Street from Intersection of 40<sup>th</sup> Avenue to 30<sup>th</sup> Avenue Intersection
- 30<sup>th</sup> Avenue from Intersection of 172<sup>nd</sup> Street to County Road J Intersection
- 180<sup>th</sup> Street from Intersection of County Road J to County Road OO Intersection
- 190<sup>th</sup> Street from Intersection of County Road J to 10<sup>th</sup> Avenue Intersection
- 10<sup>th</sup> Avenue from Intersection of 190<sup>th</sup> Street to 180<sup>th</sup> Street Intersection
- 180<sup>th</sup> Street from Intersection of 10<sup>th</sup> Avenue to 20<sup>th</sup> Avenue Intersection
- 20<sup>th</sup> Avenue from Intersection of County Road OO to 160<sup>th</sup> Street Intersection
- 170<sup>th</sup> Street from Intersection County Road OO to 170<sup>th</sup> Street Dead End

2. Except as amended by this Fifth Amendment, all other terms and conditions of the Ordinance shall remain unchanged and in full force and effect. All capitalized terms used in this Third Amendment which are not otherwise defined herein shall have the meanings ascribed to such terms in the Ordinance.
