FIRST AMENDMENT TO ORDINANCE DESIGNATING ALL-TERRAIN VEHICLE AND UTILITY-TERRAIN VEHICLE ROUTES AND REGULATING THE OPERATION OF ALL TERRAIN VEHICLES AND UTILITY TERRAIN VEHICLES IN THE TOWN OF LAFAYETTE, CHIPPEWA COUNTY, WISCONSIN

WHEREAS, the Town enacted Ordinance 2017-01 (the "Ordinance") on December 18, 2017 to designate ATV routes and regulate operation of ATVs and UTVs in the Town of Lafayette.

WHEREAS, the Town, after petition and public hearing pursuant to Section D of the Ordinance, tentatively approved changes to Section J of the Ordinance regarding ATV routes on March 19, 2018.

NOW, THEREFORE, as an amendment to the Ordinance, the Town Board enacts this First Amendment to the Ordinance (the "First Amendment"), as follows:

1. Section J of the Ordinance is deleted in its entirety and restated as follows:

J. All-Terrain Vehicle Routes

1. Routes East of County Hwy K:

- 75th Avenue from CTY HWY K to dead end
- 203rd Street from CTY HWY K to intersection of 72nd Avenue
- 72nd Ave to from intersection of CTY HWY K to intersection of 70th Avenue
- 57th Avenue from intersection of 210th Street to dead end
- 45th Avenue from intersection of 220th Street to dead end
- 216th Street from intersection of 45th Avenue to dead end
- 210th Avenue from intersection of 70th Avenue to intersection of 10th Avenue
- 220th Avenue from CTY HWY X to intersection of 10th Avenue
- 10th Avenue from CTY HWY K to intersection of 220th Street
- 20th Avenue from CTY Hwy K to intersection of 220th Street
- 30th Avenue from CTY HWY K to intersection of 220th Street
- 40th Avenue from CTY HWY K to intersection of 220th Street
- 50th Avenue from CTY HWY K to dead end

- 10th Avenue from CTY HWY K to intersection of 220th Street
- 20th Avenue from CTY Hwy K to intersection of 220th Street
- 30th Avenue from CTY HWY K to intersection of 220th Street
- 40th Avenue from CTY HWY K to intersection of 220th Street
- 50th Avenue from CTY HWY K to dead end

2. Routes West of County Hwy K:

- 197th Street from 5765 (Town Hall) to merger with 195th Street
- 195th Street from merger with 197th Street to intersection of 40th Avenue
- 50th Avenue from intersection of 195th Street to CTY HWY K
- 40th Avenue from intersection of 190th Street to CTY HWY K
- 3. No person shall operate an all-terrain or utility terrain vehicle on any Town of Lafayette street or public property not designated as an all-terrain vehicle route or trail or in the manner provided in section J of this code.
- **4.** The operation of all-terrain and utility terrain vehicles will not be permitted on state trunk highways except as may be necessary to cross the same and then in strict compliance with state law
- 5. Unless otherwise specifically provided, utility terrain vehicles shall be permitted to operate on the all-terrain vehicle routes in the same manner and subject to the same restrictions as all-terrain vehicles.
- 6. The routes and trails designated by this ordinance may from time to time be amended by action of the Lafayette Town Board after reviewing the recommendation of law enforcement regarding any such amendment. The Town Clerk shall promptly update this section upon publication of any ordinance changing the route designations provided for in this article and shall make copies of this section available to the public at the office of the Town Clerk.

K. Additional Regulations.

- 1. No person shall operate an all-terrain or utility terrain vehicle within the Town of Lafayette except as permitted under this article and subject to the state laws incorporated herein.
- 2. All-terrain and utility terrain vehicles shall not be operated on any sidewalks unless approved by Lafayette Town Board and designated with signs.
- L. Exemptions. Town of Lafayette owned vehicles are exempt from this article of the code.
- M. Effective Date. This ordinance is effective on publication or posting.

2. Routes West of County Hwy K:

- 197th Street from 5765 (Town Hall) to merger with 195th Street
- 195th Street from merger with 197th Street to intersection of 40th Avenue
- 50th Avenue from intersection of 195th Street to CTY HWY K
- 40th Avenue from intersection of 190th Street to CTY HWY K

3. Routes on County Hwy K:

- CTY HWY K from intersection of 72nd Avenue to the northern boundary of the Town of Lafayette located approximately at the midpoint of the Yellow River Bridge.
- **4.** No person shall operate an all-terrain or utility terrain vehicle on any Town of Lafayette street or public property not designated as an all-terrain vehicle route or trail or in the manner provided in section J of this code.
- 5. The operation of all-terrain and utility terrain vehicles will not be permitted on state trunk highways except as may be necessary to cross the same and then in strict compliance with state law
- **6.** Unless otherwise specifically provided, utility terrain vehicles shall be permitted to operate on the all-terrain vehicle routes in the same manner and subject to the same restrictions as all-terrain vehicles.
- 7. The routes and trails designated by this ordinance may from time to time be amended by action of the Lafayette Town Board after reviewing the recommendation of law enforcement regarding any such amendment. The Town Clerk shall promptly update this section upon publication of any ordinance changing the route designations provided for in this article and shall make copies of this section available to the public at the office of the Town Clerk.
- 2. Except as amended by this First Amendment, all other terms and conditions of the Ordinance shall remain unchanged and in full force and effect. All capitalized terms used in this First Amendment which are not otherwise defined herein shall have the meanings ascribed to such terms in the Ordinance.
