RESOLUTION 2020-02**

**A RESOLUTION GRANTING PRIVILEGES FOR OBSTRUCTION AND
IMPROVEMENTS WITHIN 167TH STREET, LOCATED IN
THE TOWN OF LAFAYETTE, CHIPPEWA COUNTY, WISCONSIN**

The Town Board of the Town of Lafayette, Chippewa County, Wisconsin, by this resolution, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

A privilege is authorized to Northern States Power Company, as applicant, to place the following obstruction or excavation within a Town of Lafayette highway at the following location:

That portion of 167th Street lying in the Northeast Quarter of the Northeast Quarter (NE ¼ NE ¼) of Section 10, Township 28 North, Range 8 West, Town of Lafayette, Chippewa County, Wisconsin, for purposes defined in the attached Temporary Construction License.

The privilege granted to Northern States Power, as applicant, to place the above-described obstruction or excavation within a town highway is subject to all of the following conditions:

- A. The applicant assumes primary liability for damages to persons or property (personal injury, death, property loss, or other damage) by reason of the granting of the privilege.
- B. The applicant is obligated to remove the obstruction or excavation upon 10 days' written notice by the town board or its agents.
- C. The applicant waives the right to contest in any manner the privilege or its revocation, or the amount of compensation charged the applicant by the town.
- D. The applicant is required to file with the town board a bond that does not exceed \$10,000 that reverts to the town and to any third parties that may be required to secure the performance of the conditions specified.
- E. The applicant is required to pay compensation into the general fund of the town in the amount of \$500.00.
- F. The applicant is not entitled to any damages from the town, its officers, officials, agents, or employees for removal of the obstruction or excavation, and if the applicant, as holder of the privilege, does not remove the obstruction or excavation upon notice by the town, it

shall be removed by the town at the expense of the applicant.


- G. This permitted privilege is granted in respect to the Project defined in the attached Temporary Construction License. In the event that applicant requires additional work in the right-of-way for 167th Street beyond the description contained in the Temporary Construction License, including cutting and removal of any pavement, this permitted privilege shall be amended and reissued with town and application mutually agreeing on additional terms and conditions for the Project.
- H. The Town Clerk shall properly post or publish this resolution as required under Wis. Stat. § 60.80. This resolution is effective on publication or posting.






