AN ORDINANCE TO ESTABLISH A PARKING VIOLATIONS BUREAU WITHIN  
THE VILLAGE.

THE VILLAGE OF AUGUSTA, KALAMAZOO COUNTY, MICHIGAN, ORDAINS:

Section 1. Pursuant to Section 8395 of P.A. 1968, No. 154 (C.L. '48 #600.8395) the Village of Augusta creates and establishes a Parking Violations Bureau for the purpose of accepting pleas of guilty in vehicle parking violation cases and to collect and retain fines as set forth herein.

Section 2. Any person receiving a ticket or complaint alleging the violation of a Village parking ordinance shall be advised as to the name and address of the Parking Violations Bureau Clerk. Such person may plead guilty to such charge before the Clerk of the Parking Violations Bureau. The Clerk shall be a Village employee and shall be appointed to such position by resolution of the Village Council..

Section 3. The Clerk of the Parking Violations Bureau shall indicate on the ticket or complaint that the plea of guilty to the complaint was made and accepted, and the person so pleading shall sign the ticket or complaint that the plea of guilty to the complaint was made and accepted, and the person so pleading shall sign the ticket or complaint as proof that such guilty plea was made.

Section 4. Upon accepting such plea of guilty, the Clerk shall collect from the violator the fine for such violation as hereafter established in this Ordinance and shall give such violator a receipt acknowledging payment of said fine.

Section 5. The amount of fines to be collected for parking offenses are as follows:

| a. Parking in an area in violation of a no parking sign or street marking | \$2.00 |
| b. Parking within five (5') feet of a fire hydrant                        | \$5.00 |
| c. Parking within twenty-five (25') feet of a corner                      | \$2.00 |
| d. Parking within five (5') feet of a driveway or alley                   | \$2.00 |
| e. Parking upon or partially upon a sidewalk                              | \$2.00 |
| f. Parking within ten (10') feet of the center of a street                | \$2.00 |
| g. Parking a vehicle for longer than permitted                            | \$2.00 |


- h. Improperly parking a vehicle \$2.00
- i. Any other parking violations \$2.00

Section 6. The Parking Violations Bureau Clerk shall retain all tickets and complaints and shall account to the Village Council at the first meeting of each month concerning the number of pleas of guilty made concerning parking violations and the amount of fines collected. The Clerk shall be entitled to be paid such compensation as may be determined from time to time by resolution of the Village Council.

The amounts collected in fines shall be turned over to the Village Treasurer to be placed in the general fund of the Village. The Parking Violations Clerk shall be entitled to reimbursement for all expenses incurred incident to performing his duties as such Clerk, and shall be reimbursed by the Village upon receipt of adequate proof of such expenses.

Section 7. Any ordinance, or part of an ordinance, in conflict herewith is hereby repealed.

Section 8. Severability. The provisions of this Ordinance are hereby declared to be severable. If any clause, sentence, paragraph, section or subsection is declared void or inoperable for any reason, it shall not affect any other part or portion thereof.
