ORDINANCE NO. 125

AMENDMENT TO ORDINANCE NO 116, NO. 117, AND NO. 121 BEING THE VILLAGE
BUILDING CODE ORDINANCES

Adopted: July 26, 1976

Effective: September 26, 1976

An Ordinance to amend the Village Building Code Ordinance, including the provisions adopting nationally recognized plumbing, mechanical and electrical codes, so as to amend any provisions in said codes pertaining to the establishment of building permit fees.

ORDAINS:

SECTION I.

The Village Building Code Ordinance No. 116 and amendments thereto being Ordinances 117 and 121, whereby the Village pursuant to Act Number 230 of the Public Acts of the State of Michigan of 1972 (MCLA 125.1501 et seq) has adopted the Uniform Building Code, 1973 edition including the index and Chapters 13, 22, 35, 38, 48, 49, 51, 57 and 70 of the appendix thereto as published by the International Conference of Building Officials; and also adopted the National Electrical Code of 1971 promulgated by the National Fire Protection Association of Boston, Massachusetts; and has also adopted the Uniform Mechanical Code, 1973 edition, Volume II issued by the International Association of Plumbing Mechanical Officials of Los Angeles, California and by the International Conference of Building Officials of Whittier, California; and has also adopted the BOCA Basic Plumbing Code, 1970 edition including accumulative supplement dated 1973, does hereby amend said Construction Codes as previously adopted, and any and

all parts or portions thereof, so as to delete and repeal any such parts or portions which contain rates for building permit fees.

SECTION II.

The Village Council shall hereafter have the authority to adopt building permit fees, including permit fees for electrical, plumbing and mechanical construction work, by resolution of the Village Council, which shall have the same force and effect as if said rates for building permit fees were contained in the Building Code Ordinances above referred to of the Village.

SECTION III.

All ordinances or parts of ordinances in conflict herewith are hereby repealed and shall be of no further force and effect on the effective date of this Ordinance. This Ordinance shall take effect sixty (60) days after adoption hereof and sixty (60) days after a certified copy of this Ordinance is delivered to the Michigan State Construction Code Commission.
