

VILLAGE OF AUGUSTA, MICHIGAN

ORDINANCE NO. 128

ADOPTED: MAY 23, 1977

EFFECTIVE: JUNE 17, 1977

An Ordinance to amend Ordinance No. 113 of the Village of Augusta, Kalamazoo County, Michigan pertaining to the storage and repair of vehicles and new or used parts thereof; and to repeal any ordinances or parts of ordinances in conflict herewith.

THE VILLAGE OF AUGUSTA

KALAMAZOO COUNTY, MICHIGAN

ORDAINS:

SECTION I

Section III, a, 2 of Ordinance No. 113 is hereby amended to provide for issuance of a hardship permit by the Police Commissioner. If such permit is denied, the appeal procedure shall be the same as that for nuisance, as specified in Section II of Ordinance No. 126.

SECTION II

Section III, a, 6 of Ordinance #113 is hereby amended to provide that the total number of days for all vehicles shall not exceed fourteen (14) in any one year, regardless of the number of days each vehicle is on the premises.

SECTION III

For the purposes of this ordinance, the word "inoperable" shall refer to any one of the following conditions:

- a. Where the vehicle is being dismantled for the sale, salvage, repair or reclamation of its parts.
- b. Where any main component such as fenders, hood, wheels, windows, doors, muffler, body, engine or essential engine parts are missing or unattached.
- c. Where the vehicle is in such a condition that it cannot be lawfully driven upon the public streets under the standards set forth in Act 300 of the Michigan Public Acts of 1949, as amended.
- d. Where the vehicle cannot be started and driven under its own power.

SECTION IV

Vehicles used exclusively for farm purposes shall be exempt from the provisions of Ordinance No. 113, but not of Ordinance No. 123, and shall also be exempt from all Sections of this Ordinance, except Section III, a,

SECTION VI

Said Ordinance of the Village of Augusta No. 113 shall remain in full force and effect, except as hereby amended. The penalty provisions contained in Section 6 of said Ordinance shall remain in full force and effect, as if set forth herein in entirety.

SECTION VII

All Ordinances or parts of ordinances in conflict herewith are hereby repealed. This Ordinance shall take effect on the 17th day of June, 1977.
