## VILLAGE OFFICERS' AND TRUSTEES' COMPENSATION

Adopted: 2-11-80

Effective: 2-11-80

An Ordinance to repeal Ordinances 64, 67, 78, 99, 106, and 136 in their entirety which pertain to compensation for Village Officers or trustees; to repeal Section 3 of Ordinance #86 pertaining to same; and to authorize the Village Council to establish all compensation, including salaries or fees for attendance of meetings by officers or trustees, by resolution hereafter; and to repeal any parts or portions of ordinances which are in conflict herewith.

## ORDAINS:

SECTION I

The Village Council shall hereafter have the authority to establish all compensation for Village officers and trustees hereafter by resolution. Such compensation shall include the right to establish salaries for officials and Trustees of the Village as well as to establish compensation to be paid for attendance of meetings by officers or trustees of the Village. Such meetings for which officers and/or Trustees may be paid as determined hereafter by resolution of the Village Council, may include regular Village Council meetings, special Village Council meetings, committee meetings of committees established by the Village Council and/or representation of the Village at public hearings, functions or meetings as may be approved by the Council.

SECTION II

Ordinance 64 dated March 24, 1955, effective April 3, 1955 pertaining to compensation for the Village President and each trustee for attending regular Board meetings is hereby repealed. Ordinance #67 dated March 11, 1958, effective March 31, 1958, providing for such compensation for the President and each trustee for attending special meetings is hereby repealed. Ordinance #78 dated February 10, 1964, effective February 20, 1964, which established salaries for the Village Clerk, Village Assessor, and Village Treasurer is hereby repealed. Ordinance #99 dated February 17, 1969, effective March 1, 1969, establishing salaries of the Village Clerk, Village Treasurer, and Village Assessor, is hereby repealed. Ordinance #106 dated February 8, 1971, effective March 1, 1971, establishing salaries for the Village Clerk, Treasurer, and Assessor is hereby repealed. Ordinance #136 dated June 12, 1978, effective June 12, 1978, establishing salaries for the Village Clerk, Assessor, and Treasurer is hereby repealed. All of the above described ordinances set forth in this Section are hereby repealed in their entirety.

SECTION III

Ordinance #86 dated July 10, 1967, effective July 30, 1967, which, in Section III thereof, provides for the salaries of the Village Clerk, Assessor, and Treasurer, is hereby amended by the repeal in its entirety of said Section III. The other sections of said Ordinance #86 shall remain in full force and effect.

SECTION IV

All other ordinances or parts of ordinances which are in conflict herewith are hereby repealed. The provisions of this Ordinance are hereby declared to be severable. If any clause, sentence, paragraph, section or sections is declared void or inoperable by any reason, it shall not affect any other part or portion thereof.
