

**VILLAGE OF AUGUSTA, MICHIGAN
ORDINANCE NO. 184**

An Ordinance to adopt by reference the Michigan Vehicle Code and Part 821 of Public Act 451 of 1994 regarding snowmobiles.

**THE VILLAGE OF AUGUSTA
KALAMAZOO COUNTY, MICHIGAN
ORDAINS:**

SECTION I
ADOPTION OF MICHIGAN VEHICLE CODE

The Michigan Vehicle Code, 1949 PA 300, as amended to date and as may be amended from time-to-time hereafter, being MCL 257.1 through MCL 257.923, is hereby adopted by reference in the Village of Augusta. References in the Code to “local authorities” shall mean the Village of Augusta. The purpose of the Code is to regulate vehicles in the Village.

SECTION II
ADOPTION OF STATE LAW REGARDING SNOWMOBILES

Part 821 of 1994 PA 451, being MCL 324.82101 to 324.82160, as amended to date and as may be amended hereafter from time-to-time, regarding the regulation of snowmobiles, is hereby adopted by reference in the Village of Augusta.

SECTION III
INCONSISTENT ORDINANCES REPEALED

Any other Ordinance, or portion thereof, inconsistent with this Ordinance is hereby repealed. Provided, however, any proceeding instituted or pending for any offense committed under any Ordinance or portion thereof may be continued until completion.

SECTION IV
SEVERABILITY

Should any part of this Ordinance be invalidated by a court, the remainder of the Ordinance shall not be affected thereby and shall continue in effect.

SECTION V
PUBLICATION; NOTICE; EFFECTIVE DATE; COPIES TO BE AVAILABLE IN
CLERK'S OFFICE

This Ordinance shall take effect upon the date of its publication, which shall be within 15 days after its adoption. The publication shall include a notice stating that the purpose of the Michigan Vehicle Code is to regulate vehicles and the purpose of Part 821 of 1994 PA 451 are available for public use and inspection at the office of the Village Clerk. Printed copies of the Code and Part 821 shall be kept in the office of the Village Clerk available for inspection by or distribution to the public during normal business hours. The Village may charge a fee that does not exceed the actual cost for copies of the Code and Part 821 distributed to the public.

SECTION VI
PENALTIES

The penalties provided by the Michigan Vehicle Code and Part 821 of 1994 PA 451 are adopted by reference for violations of the Ordinance; provided, however, that the Village shall not enforce any provision of the Michigan Vehicle Code or Part 821 for which the maximum period of imprisonment is greater than 93 days.
