VILLAGE OF AUGUSTA, MICHIGAN ORDINANCE NO. 190 ELECTION OF OFFICERS AND TERMS OF OFFICE

THE VILLAGE OF AUGUSTA KALAMAZOO COUNTY, MICHIGAN ORDAINS:

SECTION I

TITLE

This Ordinance shall be known and may be cited as the "Village of Augusta Election of Officers and term of office". The Village of Augusta ordains:

SECTION II

Election of Officers and Term of Office

There shall be elected the following Village Officers: President and six Trustees. The President and Trustees shall constitute the Village Council. These Officers shall serve for the term of office as provided by Michigan law and Village Ordinances. They shall have such power and duties as provided by law.

The office of Village Clerk and Village treasurer shall be appointed.

SECTION III

DATE OF ELECTION OF VILLAGE OFFICERS

Election of Village Officers shall be held at the Village General Election held in even numbered years. The next election of Village Officers shall be held at the General Election on November 7, 2006.

Three Village Trustees shall be elected at each biennial Village election for a term of four years and until their successor is qualified.

SECTION IV

Extension of present term of Village Officers

The terms of three Village Trustees shall be extended until the election held on November 7, 2006 and until their successor is qualified. The terms of offices presently held by Peter Crance, Bruce Bournay, and Harvey Beatty shall be extended until the election November 7, 2006 and until their successor is qualified.

The terms of the President which office is presently held by James Schultz and three Trustees which offices are presently held by JoAnn Stephens, Randall Padgett, and John Thomas shall be extended until the election held on November 4, 2008 and until their successor is qualified.

SECTION V

Repeal

All Ordinances or parts thereof in conflict herewith are hereby repealed and shall be of no further force and effect. Any and all sections, terms, provisions and/or clauses herein shall be deemed independent and severable. Should any court of competent jurisdiction hold any section, term, provision, or clause void and/or invalid, all remaining sections, terms, provisions, and/or clauses not held void and/or invalid shall continue in force and effect.

SECTION VI

Effective Date

This ordinance shall take effect 45 days after its date of adoption unless a Petition signed by no less than 10% of the registered electors of the Village of Augusta is filed with the Village Clerk within the 45 day period, in which case the Ordinance shall only take effect upon the approval at an election held on the question. Verification of signatures and submission to the electorate at the next general or special election shall be in conformance with MCL 62.1
