

VILLAGE OF AUGUSTA

ORDINANCE NO. 79

Adopted: July 13th, 1964
Effective: August 1st, 1964.

An Ordinance to prohibit parking of trucks, motor cars, or any type of vehicle on West Michigan Avenue (M96), within an area of 30 feet West from the West line of Webster Street; also to prohibit parking of trucks, motor cars, or any type of vehicle on West Michigan Avenue (M96), on the South side of West Michigan Avenue 30 feet East from the East line of East Canal Street; also to repeal any Ordinances, or parts of any Ordinances, in conflict herewith; and to set penalties for the violation of this Ordinance.

THE VILLAGE OF AUGUSTA, KALAMAZOO COUNTY, MICHIGAN, ORDAINS:

Section 1. That parking of trucks, motor cars, or any type of vehicle on West Michigan Avenue (M96), within an area of 30 feet West from the West Line of Webster Street, shall be prohibited.

Section 2. That parking of trucks, motor cars, or any type of vehicle on West Michigan Avenue (M96), on the South side of West Michigan Avenue 30 feet East from the East line of East Canal Street, shall be prohibited.

Section 3. Penalties for Violation.

Any person, or persons, who violate any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and shall be punished by a fine of not more than \$100.00, or by imprisonment in the County Jail for a period of not to exceed 90 days, or by both such fine and imprisonment.

Section 4. Severability. The provisions of this Ordinance are hereby declared to be severable, and if any clause, sentence, paragraph, section or sub-section is declared void or inoperable for any reason, it shall not affect any other part or portion thereof.

Section 5. Effective Date. This Ordinance shall take effect on the 1st day of August, 1964.
