

## VILLAGE OF AUGUSTA

ORDINANCE NO. 87

Adopted: July 10, 1967

Effective: July 30, 1967

An Ordinance to revoke Ordinance No. 3, Section 4; to regulate the lighting of fires in public places and right of ways; and to amend sections of Ordinance No. 36 and to revoke any other Ordinances, or parts thereof, of Ordinances in conflict herewith.

## ORDAINS:

Section 1. Section 4, Ordinance No. 3, enacted the 16th day of September, 1895, entitled, "An Ordinance Relative to Fire Wardens", be and the same is hereby revoked.

Section 2. Ordinance No. 9, enacted on the 16th day of September, 1895, entitled, "An Ordinance Relative to Building Fires," be and the same is hereby repealed.

Section 3. It shall be unlawful for any person to light, ignite, fire or cause to be set on fire, any papers, shavings, excelsior, or other highly inflammable material upon any of the public streets, parks, bridges or alleys in the Village of Augusta, except at such times as the President may grant permission to do so by proclamation.

Section 4. Section I of Ordinance No. 36, enacted the 8th day of May, 1911, entitled, "An Ordinance to Establish Fire Limits and Regulations for the Prevention of Fires", be and the same is hereby amended to read as follows: That all of the territory contained within the corporate limits of the Village of Augusta is hereby constituted and designated as the "fire limits" of the Village of Augusta.

Section 5. Sections II, III, IV, V, VI, and VII of Ordinance No. 36, enacted the 8th day of May, 1911, entitled,

"An Ordinance to Establish Fire Limits and Regulations for the Prevention of Fires", be and the same are hereby repealed.

Section 6. Any Ordinance or part of an Ordinance in conflict herewith is hereby repealed.

Section 7. Severability. The provisions of this Ordinance are hereby declared to be severable and if any clause, sentence, paragraph, section or sub-section is declared void, or inoperable, for any reason, it shall not affect any other part or portion thereof.

Section 8. Any person who shall violate this Ordinance or any part thereof shall be deemed guilty of a misdemeanor and upon conviction thereof, shall be punished by a fine not exceeding \$100 and/or not more than 30 days in the county jail, together with the costs of prosecution.

Section 9. This Ordinance shall take effect on

July 30, 1967.
