WHEREAS, the Door County Board of Supervisors held a public hearing concerning the Preliminary County of Door Supervisory District Plan on May 24, 2011; and

WHEREAS, The Preliminary County of Door Supervisory District Plan was approved by the County Board on May 24, 2011; and

WHEREAS, the Preliminary County of Door Supervisory District Plan must be sent to Door County municipalities for division of wards,

NOW THEREFORE, BE IT RESOLVED by the Town Board of the Town of Forestville, Door County, Wisconsin that the Preliminary County of Door supervisory District Plan be and is hereby approved.

BE IT FURTHER RESOLVED that the Town of Forestville establishes Two (2) Wards described as follows:

Town of Forestville, Ward 1 - Commencing at the NW corner of Section 6, T26N-R25E, thence Easterly along the North Town line approximately 4.25 miles to the centerline of Maple Road, thence Southerly along centerline of Maple Road approximately 1.5 miles to the intersection with Maplewood Road, thence Westerly along centerline of Maplewood Road approximately 1.25 miles to the intersection with County Trunk O, thence Southerly along centerline of County Trunk O approximately one-half mile to the intersection with Old Elm Road, thence Westerly along centerline of Old Elm Road approximately one mile to the intersection with State Highway 42, thence Southerly along centerline of State Highway 42 approximately 2.5 miles to the North boundary of the Village of Forestville, thence Easterly along the Village limits and centerline of Brans Road approximately 2,280 feet, thence in a Southerly and Westerly direction along the Village of Forestville limits for approximately one mile to the intersection of the Town - Village boundary with the centerline of Gaede Road, thence Southerly approximately one-half mile along centerline of Gaede Road to the intersection with the South Town line, also being the approximate intersection with County Trunk X, thence Westerly along South Town line and along County Trunk X approximately two miles to the SW corner of Section 31 T26N-R25E, thence Northerly along West Town line approximately six miles to the point of beginning, excepting the Village of Forestville.

Town of Forestville, Ward 2 – Commencing at the NE corner of Section 1, T26N-R25E, thence Westerly along the North Town line approximately 1.75 miles to the centerline of Maple Road, thence Southerly along centerline of Maple Road approximately 1.5 miles to the intersection with Maplewood Road, thence Westerly along centerline of Maplewood Road approximately 1.25 miles to the intersection with County Trunk O, thence Southerly along centerline of County Trunk O approximately one-half mile to the intersection with Old Elm Road, thence Westerly along centerline of Old Elm Road approximately one mile to the intersection with State Highway 42, thence Southerly along centerline of State Highway 42 approximately 2.5 miles to the North boundary of the Village of Forestville, thence Easterly along the Village limits and centerline of Brans Road approximately 2,280 feet, thence in a Southerly and Westerly direction along the Village of Forestville limits for approximately one mile to the intersection of the Town – Village

boundary with the centerline of Gaede Road, thence Southerly approximately one-half mile along centerline of Gaede Road to the intersection with the South Town line, also being the approximate intersection with County Trunk X, thence Easterly along South Town line approximately four miles to the SE corner of Section 36 T26N-R25E, thence Northerly along East Town line and County Trunk S approximately six miles to the point of beginning.

BE IT FURTHER RESOLVED that the Town Hall located at 7701 County H, Town of Forestville shall be the official polling place for the Town of Forestville Wards 1 and 2 of the County of Door Supervisory District Plan.
