

MAPLEWOOD SANITARY DISTRICT NO. 1

DESCRIPTION

A tract of land being a part of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$, SW $\frac{1}{4}$ of the SW $\frac{1}{4}$, and SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 4; the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ and NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 9; the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$, and NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 8; and SW $\frac{1}{4}$ of SE $\frac{1}{4}$, SE $\frac{1}{4}$ of SE $\frac{1}{4}$ and NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 5, in the Township of Forestville, described as follows:

Beginning at a point in the center line of County Trunk Highway "H" at a point 1927 feet West of the intersection of County Trunk Highway "H" and State Highway No. 42; Thence North 300 feet; Thence East parallel to the center of County Highway "H" 1627 feet to a point 300 feet West of the center of State Highway No. 42; Thence North parallel with the center of State Highway No. 42, 1062 feet; Thence East 300 feet to the center of State Highway No. 42; thence East 300 feet; Thence South 1062 feet to a point 300 feet North of the center of County Highway "H"; Thence East parallel with County Highway "H" 2046 feet; Thence South 300 feet to the center of County Highway "H"; Thence South 300 feet; Thence West parallel with the center of County Highway "H" 2046 feet to a point 300 feet from the center of State Highway No. 42; Thence South parallel with the center of State Highway No. 42, 1026 feet; Thence West to the center of State Highway No. 42, 300 feet; Thence West 300 feet; Thence North parallel with the center of State Highway No. 42, 1026 feet to a point 300 feet South of the center of County Highway "H"; Thence West parallel with the center of County Highway "H", 1627 feet to appoint 300 feet South of the point beginning; Thence North 300 feet to the point of beginning.
