WHEREAS, The Preliminary County of Door Supervisory District Plan was approved by the County Board on September 21, 2021; and

WHEREAS, the Preliminary County of Door Supervisory District Plan must be sent to Door County municipalities for division of wards,

NOW THEREFORE, BE IT RESOLVED by the Town Board of the Town of Forestville, Door County, Wisconsin that the Preliminary County of Door Supervisory District Plan be and is hereby approved.

BE IT FURTHER RESOLVED that the Town of Forestville establishes Two (2) Wards described as follows:

Town of Forestville Ward 1 - Commencing at the Northwest corner of Section 6, T26N-R25E, thence easterly along north line of Section 6 to Northeast corner of Section 6 being the centerline of Stone Road, thence southerly along east line of Section 6 to Southeast corner of Section 6 which is the intersection of Stone Road with the centerline of County Highway H, thence Easterly along centerline of County Highway H to North one-quarter of Section 8, T26N-R25E being the centerline of Mill Road, thence Southerly along centerline of Mill Road to South one-quarter of Section 8 being the centerline of Old Elm Road, thence Easterly along centerline of Old Elm Road to Northeast corner of Section 17, T26N-R25E being the centerline of State Highway 42, thence Southerly along the centerline of State Highway 42 to the north line of the Village of Forestville limits approximately 13,829 feet, thence Westerly and Southwesterly along the Village of Forestville limits to the south line of Southeast one-quarter of the Northeast one-quarter of Section 32, T26N-R25E, thence Easterly along south line of SENE to East one-quarter corner of Section 32 which is the centerline of Gaede Road, thence Southerly along centerline of Gaede Road which is the east line of Section 32 to South line of Section 32, thence Westerly along South line of T26N - R25E to Southwest corner of Section 31, T26N-R25E being the west line of T26N-R25E, thence Northerly along West line of T26N-R25E to the point of beginning.

Town of Forestville Ward 2 - Commencing at the Northeast corner of Section 1, T26N-R25E, thence westerly along the north line of T26N-R25E to the Northwest corner of Section 5, T26N-R25E being the centerline of Stone Road, thence southerly along the west line of Section 5 to Southwest corner of Section 5 which is the intersection of Stone Road and the centerline of County Highway H, thence Easterly along the centerline of County Highway H to the North one-quarter of Section 8, T26N-R25E being the centerline of Mill Road, thence Southerly along the centerline of Mill Road to the South one-quarter of Section 8 being the centerline of Old Elm Road, thence Easterly along the centerline of Old Elm Road to the Northwest corner of Section 16, T26N-R25E being the centerline of State Highway 42, thence Southerly along the centerline of State Highway 42 to West one-quarter of Section 28, T26N-R25E being the centerline of Brans Road and the north line of the Village of Forestville limits, thence Easterly along the Village limits and centerline of Brans Road approximately 2,280 feet, thence Southerly and Southwesterly along the Village of Forestville limits to centerline of Gaede Road, thence Southerly along the centerline of Gaede Road which is the west line of Section 33, T26N-R25E to the South line of Section 33, thence Easterly along South line of T26N-R25E to Southeast corner of Section 36, T26N-R25E being the east line of T26N-R25E, thence Northerly along east line of T26N-R25E to the point of beginning.

BE IT FURTHER RESOLVED that the Town Hall located at 7701 County H, Town of Forestville shall be the official polling place for the Town of Forestville Wards 1 and 2 of the County of Door Supervisory District Plan.
