Town of Lake Mills Police Department Fee Schedules

WHEREAS, the Town of Lake Mills Board has determined that it is prudent to create and update periodically a General Fee Schedule for the Police Department, to provide efficiency, economy and uniformity in establishing and adjusting the fees charged by the Town of Lake Mills Police Department as enumerated throughout the Town of Lake Mills Code of Ordinances and for administrative purposes into an abbreviated general schedule, and

WHEREAS, the fees set forth in the Fee Schedule append the fees in the Town of Lake Mills Code of Ordinance, and

WHEREAS, the fees set forth in the Fee Schedule may be added to or amended from time to time by adoption of a Resolution, and

WHEREAS, the Town Board shall review the Fee Schedule on at least an annual basis for the purposes of adjusting and updating the fees charged by the Town Police Department, and any amendments or additions thereto may be made by Resolution, and


WHEREAS, the fees set forth in the Fee Schedule shall supersede any fee established elsewhere in the Town's Code of Ordinance for the same charge. If a fee is set forth elsewhere in the Town of Lake Mills Code of Ordinance or via a Resolution, and there is no corresponding fee set forth in the attached Fee Schedule, the fee set forth elsewhere in the Code of Ordinance or the Resolution shall control until such time as a fee for the same charge is established in the Fee Schedule, and

WHEREAS, the Town gives the authority to collect fees outlined on the Fee Schedule on behalf of the Town Police Department,


