FY15-16 Budget & Tax Rate

The Board of Aldermen approved the budget for Fiscal Year 15-16 (Oct. 1, 2015 – Sept. 30, 2016) and approved the 2015 tax rate.

The tax rate has been reduced to 10.59 cents/\$100 valuation from 11.25 cents last year. This new tax rate coupled with the increased property valuations by Burnet County Appraisal District will result in basically the same tax income to the City as last year.

The largest part of our budget (approx. 50%) is for Public Safety (Fire and EMS Services). These services are critical to our community's safety. The contracts for these services increase approx. 3% annually.

Speeding Vehicles

We have received a number of complaints from citizens regarding speeding vehicles in Highland Haven. We ask that all drivers including residents, guests <u>and contractors</u> please slow down. We have residents who regularly use our streets to walk and ride bicycles. <u>Please make a special effort to ask your lawn maintenance</u> contractor to slowdown.

Walking and Biking at dusk/night

Lately I have encountered several people walking and biking at night dressed in dark clothing without lights or reflectors. Please be safe and dress in light colored clothing <u>AND</u> carry a light if you are walking after sundown. If you are biking after sundown, please be safe by installing reflectors and lights on bicycles <u>AND</u> wear light colored clothing.

Property Maintenance - Ordinance #58

The cooler *Fall* weather is a perfect time to cleanup around your house and dispose of unwanted items stacked in the backyard, garage or carport. This is also the time to check your home for any required maintenance, especially the exterior of your house. Take advantage of this time of the year and prepare your house for *WINTER*! A number of houses and outbuildings have been observed with visible exterior damages that will lead to pest infestation as winter approaches.

Vehicle Parking Ordinance #59

We have received numerous complaints about vehicles, golf carts, jet skis, etc. being parked in grass areas. All such vehicles should be in your driveway, on a concrete surface, or a hard surface (e.g. concrete, asphalt or paver pads). Parking in your yard or regularly, parking on the street shoulder is a violation of this ordinance.

Street Maintenance

We have been evaluating street conditions and most are in a good state of repair. This is the second year that the streets have not required chip and seal coating. We have identified a number of areas requiring patching. These repairs will be scheduled in the coming months. Asphalt bleeding problems were addressed this year by applying sand to the worst areas. Many thanks to **Burnet County**, **Bill Passmore**, **Robert Dahlstrom** and **Ronnie Dauphin** for assisting with the sanding operation.

Emergency Preparedness / FEMA Hazard Mitigation Plans

Texas encounters at least one major disaster nearly every calendar year. We regularly face floods, wildfires, tornadoes, hurricanes and other severe weather. It is time to get prepared.

Everyone is encouraged to assemble a disaster supply kit of important emergency supplies including a first aid kit, battery operated radio, flashlight, medication, non-perishable food items, and bottled water. Be aware of where the nearest storm shelter is located, know where you and loved ones will go if an evacuation is necessary, and develop an emergency plan for communicating with family and friends.

FLOODPLAIN TIDBITS

Governor Greg Abbott has declared September as "Preparedness Month in Texas" to coincide with National Preparedness Month. Had the Wimberley Flood rains happened over our Highland Haven/Shady Acre area, I am certain we would have had water in several of our homes. We ALL need an emergency supply kit of important emergency supplies including first a first aid kit, a NOAA Weather Radio or battery operated radio, flashlight, medication, non-perishable food items and bottled water. A really good website to visit: http://www.dps.texas.gov/dem/ThreatAwareness/nationalPrepAwaremess.htm.

You also need to know where personal data, bank records, family records are located and have them centrally located for quick evacuation should we need to do so.

We have finished our local TCRFC Hazard Mitigation meetings in anticipation of having the necessary data to complete our extension of our Flood Ordinance so that we, as a community, would have access to emergency FEMA monies in event of a flood. Our current Ordinance expires end of year. Our data has now been turned in to TCRFC, Tetratech and Halff & Assoc. for compilation and completion.

Lastly, Irene Dauphine, our former Mayor, sent out a request to complete a Survey regarding Burnet County Hazard Mitigation. In all of Burnet County, there were 120 total Surveys returned. We are extremely proud that Highland Haven residents submitted 96 of them. Way to go Highland Haven!!!
