Next Meeting: Tuesday, May 3rd 7:00 pm Community Center



The Highland Haven POA will meet at 7:00 pm on May 3rd at the Community Center. This is one of the four regularly scheduled meetings of the board. This session we will be working through the usual items of financials, covered and uncovered storage and maintenance contracts. We will also be reviewing the maintenance planned for the parks. Key points will be the budget for the year and discussion of the proposed rate increase of storage for the covered and uncovered spaces and sheds.

While no one likes an increase of any product or commodity one purchases, the cost of our park maintenance continues to go up as well. Our plan is to increase the rates as minimally as possible and our study of the surrounding area facilities indicates that we will still be way below the rates of those facilities.

There will also be a POA member vote to allow the building of a retaining wall at Redbird Park. The wall will provide a protective structure providing functional support for keeping soil in place, reducing maintenance and preventing erosion. The wall will be gift to the community as the construction and materials will be donated by Jim and Willa Holgate.

- We continue to receive complaints from residents regarding ordinance violations including:
 - o No more than one sign per political candidate in the yard- Ord. #56
 - o Too many pets at a residence Ord. #36
 - o Loud barking dogs Ord. #36
 - O Homes in dire need of repair Ord. #58
 - o Cluttered carports visible from the streets. Ord. #58
 - o Trash and debris in yards visible from streets and parks Ord. #58 & #37
 - o Parking trailers, golf carts and other vehicles in yards and right of ways Ord. #59
- Warning letters and citations to the property owners are the next steps for violations.
- Help us maintain the quality of life we enjoy here in Highland Haven.
- "Voluntary Compliance" is very much appreciated by everyone!

Ord. #36, Animal Control Ordinance

"Any animal causing excessive and/or continuous noise found objectionable by residents of City must be restrained within the residence ... so that the noise may not be heard by other residents of The City."

"...unlawful to maintain more than two (2) dogs and/or two (2) cats per household within the city limits of The City."

Ord. #37, Maintenance of Hedges and Fences

Section 4. RESTRICTIONS AND REQUIREMENTS

"C. Shrubs, bushes and other vegetation planted for the purpose of screening, or in such a manner as to create a hedge, shall be maintained at a maximum height of six (6) feet."

Ord. #58, Maintenance of Structures and Lots

"Property owners shall maintain residence and outbuildings in a manner that does not detract from neighborhood appearance and the property values of adjacent property owners. Maintenance includes, but is not limited to, periodic painting, masonry repair as needed, replacement of damaged windows and screens, and roof repairs."

Ord. #59, Parking and Storage of Vehicles Section IV. STORAGE OF VEHICLES

"1. Storage in residential districts: Storage of all types of vehicles, to include trailers, in residential districts is limited to carports, garages, and upon a hard surfaced pad behind a privacy fence in side or rear yards."

Safety On Our Streets "Drive like your kids and grandkids live here!"

- We have received complaints from residents in the Redbird/Blackbird area about drivers speeding through the intersection near the Community Center. Please slow down and check for vehicles <u>and</u> pedestrians on these streets before proceeding through this intersection.
- Complaints have been received re: underage youth operating golf carts on city streets. Drivers must be legal drivers and must obey all traffic laws. Ord. #59
- Please do not block roadways. If you wish to talk with someone, pull to the side of the street.

Emergency Preparedness / FEMA Hazard Mitigation Plans

Regional Notification System (Emergency Notification System)

- Capitol Area Council of Governments (CAPCOG) Regional Notification System (RNS) uses a "reverse dialing" method to notify residents in the 10-county region of critical emergency information in situations where property or human life are in danger. It also can be used to notify residents of other events that affect them.

LCRA Floodgate Operations Notification Service (FONS)

- Free service to notify subscribers of floodgate operations at any of the Highland Lakes dams.
- The Floodgate Operations Notification Service (FONS) allows people to specify how they want to be notified of floodgate operations: email, text and/or phone call.
- FONS is not a flood warning system.

Streets and Drainage

- Check the drainage areas around your home and make sure that the culverts are open and drainage ditches (swales) between houses are maintained so storm water is carried away.

- Starting a project before receiving a building permit will result in a "Stop Work Order", higher fees and possible removal of your project.
