If you attended the biannual meeting on February 8th, we did vote on Chapman's Dock's to make the repairs. In early May, new xeriscape landscaping will be planted at the community center. It will give the building a fresh new look! - The Mayor has daily contact with the Texas Division of Emergency Management and has been sending out updated information as it is received. We receive 25+ email updates daily along with regular conference calls with State health and governmental officials regarding the pandemic.
- Residents have found unique ways to keep in touch and still "practice social distancing".

 - o Zoom, Google, Skype and other electronic video meeting formats
 - One small group met in Dove Park on golf carts maintaining 6' spacing.
 - Another small group was chatting with neighbors while seated in lawn chairs in a driveway maintaining 6' spacing.
- "Thanks" to the many residents that have been busy assisting with meals for those in need and sewing masks for first responders and residents.

- Slow the Spread of the Coronavirus
 - o Practice "social distancing", avoid gatherings and keep 6'space between people, even while walking and jogging.
 - o Wash hands for 20 seconds frequently and encourage others to do the same.
 - o Cover coughs and sneezes with tissue and dispose of it properly to avoid spreading virus.
 - o Avoid touching eyes, nose and mouth with unwashed hands.
 - o Disinfect surfaces, buttons, handles, knobs and other places touched often.
 - Avoid contact with sick people.
 - o Stay at home if you are sick and contact your health provider by phone for advice.
 - o CDC recommends using simple cloth face coverings in public to help slow the spread of the virus, especially at grocery stores and pharmacies.

Public Safety

- The Sheriff's Office asked that in the future, residents should immediately report to them any suspicious vehicles, vandalism and especially theft activity so they can investigate.

 - o Only Checks or Credit Cards are accepted.
- Recommend you call before making the trip to Burnet to confirm what trash they will accept.
- Trash service customers have been asking where to take bulk recycling items. Hill Country Recycling accepts all scrape metals, cardboard and paper products. They do not accept plastics. For information call them at 830-693-3667. www.hillcountryrecycling.com

Traffic/Parking

- Only golf carts and utility vehicles like a "Mule" are allowed on City streets. ATVs are not allowed on any street.
- Only licensed drivers are allowed to operate motorized vehicles on any street.

- Reminder: all water bills are due at City Hall by 5pm on the 15th of each month.
- On-line bank payments are many times received well past the due date. Bank clearinghouses may process your payment before the due date; however, the check is not received at City Hall until after the due date. Please contact your bank and confirm your payments will mailed in time to reach us by the 15th.

Home and Yard Maintenance

- Property owners are required to trim shrubbery, especially at street intersections and on right of ways. There are several intersections where bushes are now blocking the view of on-coming traffic.
