Board of Alderman

- The Board of Alderman has approved our FY20-21 budget and adopted the 2020 tax rate.
- Our tax rate will change from .1221 to .1321 per \$100 property value. This is effectively an 8% increase. Highland Haven continues to have the lowest tax rate of any city on Lake LBJ!
- The proposed budget also includes a 3% increase on residential water rates.
- The Board authorized the Mayor to order a special election to adopt 2% local sales and use tax. This item will be included on the ballot for the November elections. This will allow our community to benefit from sales taxes currently being collected for online purchases.
- BOA meetings are open to the public. Residents and property owners are encouraged to attend.
- The next BOA Meeting is scheduled for **Tuesday**, **September 15**, **7pm**.
- Due to the COVID-19 pandemic, the BOA meetings are held in the Community Center to provide space for social distancing. Face masks are required. Seating is limited.
- THANK YOU to our BOA members Terry Smith, Don Hagans, Terry Nuss, Lorinda Peters and Lynn Smith for committing the time required to consider & approve the 2020-2021 budget for our city.

Signs

- As the political races pick up speed, please take a moment and review Ordinance #56 regarding signs.
 - o Only one sign per candidate may be placed in the property owner's yard.
 - o Signs cannot be placed in the street right-of-way.
 - O Signs can be no larger than 24"x36".

Ordinance Enforcement

- Residents have been complaining that our ordinances are not being enforced adequately.
- Alderman **Don Hagans** has been working diligently sending out violation notices to property owners and residents. **If you receive a notice, please correct the violation immediately**. If you have questions about the notice or the ordinance, please call City Hall.
- Several property owners correct their violation <u>temporarily</u> and then revert to violating the same ordinances. The City would like to avoid issuing citations, so please help us by obeying our ordinances.
- Property owners and residents are urged to advise their guests and contractors of our ordinances.
- Specific complaints include:
 - Vehicles and trailers that are parked on lawns and blocking streets. Complaints include resident, guest, as well as lawn/construction contractor vehicles.
 - o Contractors are not working within authorized work periods (7am-7pm, Monday-Saturday)
 - o Homes and yards are not being maintained according to our ordinances.
- New residents often remark that they chose to live in Highland Haven because it is a beautiful and well-maintained community.
- Help us keep Highland Haven the best place to live on Lake LBJ!

Public Safety

- To keep our streets safe, please advise residents, guests, and contractors to observe traffic laws and be safe while walking on our streets.
- Traffic related complaints received from residents have increased greatly and include:
 - o Drivers and pedestrians are not following the "rules of the road"
 - o Unsafe actions such as <u>speeding and running stop signs</u> and includes vehicles driven by residents, guests, and contractors (lawn and construction).
- Let's keep our streets safe for everyone!

Traffic/Parking

- Vehicles and trailers can only be parked on hard surface driveways. Stored vehicles must be placed in a garage. Parking in yards is prohibited. <u>If you need additional hard surface parking space, please consider adding such.</u> Contact our Building Permits Officer for more information.
- Only golf carts and utility vehicles like a "Mule" are allowed on City streets. ATVs <u>are not</u> allowed on any street.
- Only licensed drivers are permitted to operate motorized vehicles on city streets. This includes golf carts.
- Help us keep streets open for emergency vehicles! Do not allow vehicles to block streets.

- Property owners are required to trim shrubbery, especially at street intersections and on right of ways. There are several intersections where bushes are now blocking the view of on-coming traffic. - There are many trees in the neighborhood that extend over the street and are too low. All trees over the street need to be at least 15 feet above street level. Please check your and trim them as necessary.

Fire Safety

- <u>Burn Ban is now in effect!</u> Outdoor burning is prohibited.
- <u>Many properties have brush piles that are expanding.</u> These piles are a fire hazard and need to be removed as soon as possible. Do not continue to add brush to them.
