- The Board of Alderman authorized the Mayor to order a special election to adopt 2% local sales and use tax. This item will be included on the ballot for the November elections. This will allow our community to benefit from sales taxes currently being collected from our residents for their online purchases. Ordinance Enforcement

- Residents have been complaining that our ordinances are not being enforced adequately.

Public Safety

- To keep our streets safe, please advise residents, guests, and contractors to observe traffic laws and be safe while walking on our streets.
- Let's keep our streets safe for everyone!

Traffic/Parking

- Vehicles and trailers can only be parked on hard surface driveways. Stored vehicles must be placed in a garage. Parking in yards is prohibited. <u>If you need additional hard surface parking space, please consider adding such.</u> Contact our Building Permits Officer for more information.
- Only golf carts and utility vehicles like a "Mule" are allowed on City streets. ATVs are not allowed on any street.
- Only licensed drivers are permitted to operate motorized vehicles on city streets. This includes golf carts & utility vehicles.
- Help us keep streets open for emergency vehicles! Do not allow vehicles to block streets.

Signs

- As the political races pick up speed, please take a moment and review Ordinance #56 regarding signs.
 - o Only one sign per candidate may be placed in the property owner's yard.
 - O Signs cannot be placed in the street right-of-way.
 - O Signs can be no larger than 24"x36".

- Please be considerate of your neighbors when planning your lawn maintenance and outdoor activities.
 - o Try to schedule lawn maintenance activities between 7am-7pm Monday Saturday.

Home and Yard Maintenance

- **Property owners are required to trim shrubbery, especially at street intersections and on right of ways.** There are several intersections where bushes are now blocking the view of on-coming traffic. Fire Safety

- Burn Ban has been lifted and outdoor fires are now allowed.
- Please take this opportunity to get rid of brush piles. Do not burn construction materials.
 - o <u>Call Granite Shoals Fire Dept. and the Burnet County Sheriff's Office prior to starting any outdoor</u> fires.
 - Ord. #27 RULES FOR A CONROLLED BURN:
 - 1. The fire has to be manned all the time the fire is burning.
 - 2. The fire cannot be started before sunrise and has to be out by sundown.
 - 3. Water has to be readily available on the site in order to control the fire.
 - 4. Rubber or plastic goods cannot be burned.
 - 5. No controlled burns on Sunday.
 - 6. Fire is to be no closer than 50 feet to any structure.

- The Governor and the Texas Department of Health Services still recommend the following:
 - o Practice "social distancing", avoid gatherings and keep 6'space between people, even while walking and jogging.
 - o Wash hands for 20 seconds frequently and encourage others to do the same.
 - o Cover coughs and sneezes with tissue and dispose of it properly to avoid spreading virus.
 - o Avoid touching eyes, nose and mouth with unwashed hands.
 - o Disinfect surfaces, buttons, handles, knobs and other places touched often.
 - Avoid contact with sick people.
 - O Stay at home if you are sick and contact your health provider by phone for advice.
 - Using a simple cloth face covering in public will help slow the spread of the virus, especially in interior public spaces.
