Notice to all Residents and Property Owners

- Our water system is completely operational. During the recent severe winter weather, many houses had frozen and broken water lines and plumbing fixtures.
- If your water was turned off using the City meter valve, call the City to have it turned back on. **Do not attempt to operate this valve.** These valves can be easily damaged and require costly repairs, for which the property owner will be responsible.
- Property owners can use the "property owner cutoff valve" to turn off their water service.
 - This valve may be inside the meter box or just outside the meter box and usually has a handle easily turned by the property owner
- During the recent severe weather event, we found that many property owner cutoff valves were:
 - o Completely covered and inaccessible
 - o Inoperable and needed replacement
- Property owners need to locate this valve and have a plumber replace it if it is inoperable.
- Call the City if you need assistance with locating your property owner cutoff valve.
- Property owners are urged to inspect all plumbing lines and fixtures (including water softeners and hot water heaters) immediately for leaks. Be sure to inspect water well systems and waterfront structures that are connected to a water system.
- Non-resident property owners are urged to visit their houses as soon as possible to inspect their property and make repairs. Some houses had water line breaks inside the house and incurred interior damage which if left unrepaired could generate costly mold remediation.

Severe Winter Weather Thanks

- Thanks to Pedernales Electric Coop for power restoration and preventive tree trimming. PEC deployed crews that worked around the clock for 2 days re-establishing power and trimming trees that were knocking out primary electrical lines.
- Thanks to Jim Luther, County Commissioner, for sanding our bridge and keeping us informed on road conditions. Jim also delivered cases of bottled water for anyone that needed drinking water.
- Thanks to County Judge James Oakley for coordinating emergency efforts throughout the County, monitoring our power outages and coordinating with PEC.
- Thanks to Sunset Utilities including Ricky Rowe and Pete Freehill for working around the clock keeping our water system up and operational.
- Thanks to all of the neighbors who were checking on and helping neighbors! This is what makes our community special!

Public Safety/Street Maintenance

- The Board approved changing the "YIELD" sign at 100 Flamingo to a "STOP" sign. Residents have been concerned about traffic safety at this location due to limited sight lines.
- The intersection of Redbird and Blackbird is now a 3-way STOP.
- To keep our streets safe, please advise residents, guests, and contractors to observe traffic laws and be safe while walking on our streets.
- Let's keep our streets safe for everyone!

HH Water System

- The rolling backouts caused a few problems for our generator system and we have already begun scheduling these repairs.
- During the severe winter weather, we had many homes with major water lines breaks. These open lines were flowing so much water that at one point our water wells could not keep up with the flow and the level of our <u>ONLY</u> storage tank was quickly approaching a critical level. An emergency email message was sent to the community (including Shady Acres and Nobles) asking residents to check their homes and their neighbors for broken plumbing and immediately report broken water lines.
- YOUR response was outstanding!! We were able to immediately isolate those homes with broken water lines. YOUR action immediately reversed our falling water levels in our ONLY storage tank.
- We continued to monitor and isolate homes with broken plumbing lines for the next 2 days as temperatures rose and frozen lines thawed.
- Daily water use is still much higher than what is typical for this time of the year. Continue looking for and reporting any suspected water leaks to City Hall.

Board of Alderman

- Candidate filing was open from January 13- February 12 for 3 alderman positions. By the closing of filing period, only 3 applications were received. Those applications were submitted by the 3 incumbents and the Board of Alderman will consider cancelling the election at their March 2nd Board of Alderman meeting.
- Aldermen and the mayor serve 2-year terms and the terms are staggered. Three (3) alderman positions are scheduled for election every other year and 2 alderman and the mayor positions in the alternate year.
- Incumbents who will be completing their terms include: **Alderwoman Lorinda Peters**, **Alderwoman Lynn Smith** and **Alderman Terry Smith**.
- BOA meetings are open to the public. Residents and property owners are encouraged to attend.
- Due to the COVID-19 pandemic, the BOA meetings are held in the Community Center to provide space for social distancing. Face masks are required. Seating is limited.

- Outdoor fires must be continually monitored and must be completely out by sundown.
