- Residents have asked the City to consider implementing a single residential garbage service for the community. The City will soon be sending out a survey asking property owners and residents for their input regarding such a service. The survey will be sent out similar to how you receive the newsletter. HH Water System

- Protecting our drinking water is everyone's responsibility. TCEQ requires municipal water systems to monitor and guard against any cross connection with other water sources such as wells and lake irrigation systems. Please help us keep our water safe by checking your water systems to make sure there are no cross connections. If you need assistance call City Hall.
- Please help our meter readers by trimming shrubs and grass from around water meters.

Traffic Safety

- There have been numerous complaints from residents about speeding and reckless driving. We have contacted the Sheriff's Office to assist with monitoring traffic in our community.
- Help keep Highland Haven safe by observing State traffic laws and local ordinances.
- Only golf carts and "Mule" type vehicles can be operated on City streets.
- Carts operated at night and during low light periods must have and use head and tail lights.
- All carts must be equipped with a reflective triangular "slow moving vehicle" sign.
- Only licensed drivers can operate motorized vehicles on City streets.

Fire Safety/Yard Cleanup

- County wide Burn Ban has been lifted. http://www.burnetcountytexas.org/page/environ.burn
- Contact the Burnet County Sheriff's Office and the Granite Shoals Fire Dept. <u>before</u> starting any outdoor fires. Their phone numbers can found on the first page of the Highland Haven Directory.
- Construction materials such as boards and plywood cannot be disposed of by burning.
- Please cleanup any brush and leaf piles to reduce fire hazards.
- Warmer weather also means snakes and other pests are starting to move about and brush piles provided create nesting areas. There have been several reports of snake bites in Burnet County in the past few weeks.
- Do not use the lake for dumping anything, including leaves and grass clippings.
- Granite Shoals Fire Dept. needs volunteer firefighters and non-emergency staff. Call Chief Austin Stanphill at 830-596-8110 for more information.

- Please review our ordinances before starting <u>any</u> additions or construction projects on land or water (including floating Jet Ski docks and fences).
- Starting a project before receiving a building permit will result in a "Stop Work Order", higher permit fees and possible removal of your project.

Streets and Storm Water Drainage

- Check drainage around your property and clear any potential blockage to avoid flooding.
- Be sure to clean leaves from roof rain gutters.
- Clear driveway drainage pipes and maintain drainage ditches around your property.

HHPOA Park Properties are for the recreational use of property owners, their families and guests and renters. The parking of vehicles in the parks for the purpose of anything other than physically using the park or while on the water is prohibited. Park hours are 5 a.m. to 11 p.m. daily.

HHPOA Members, guests and renters must display their sticker on or valid guest pass in their vehicle while in the parks or be subject to prosecution. Stickers are to be displayed in the lower right corner of the rear window. HHPOA Member golf carts are permitted in the parks without the use of a sticker or guest pass. If you need a sticker please contact **Noveleen Parker**. If you see vehicles parked that do not have stickers you may contact any Board Members who will notify violators of our policy or contact our constable, **Leslie Ray at 512-756-8080**.

Guest passes are available. The cost of a guest pass is \$5.00. A pass can be obtained from any board member. The maximum time period allowed on a guest pass is one week.

Property owners, renters and guests are responsible for their own cleanup.

No dumping or burning of any kind is permitted in the park unless authorized by the Board.

No overnight parking/camping is permitted in the parks.

Excessive noise is prohibited in the parks.

All persons in the park will remain clear of the boat ramp while swimming or playing. The boat ramp is exclusively reserved for the launching and recovery of boats. Parking is not allowed on the boat ramp.

All parties enjoying and participating in motor boating and jet skiing will remain a minimum of 15 feet offshore except when launching, recovering or beaching watercraft.

Children under the age of 12 must be attended by an adult property owner or their guest. Underage consumption of alcoholic beverages is not allowed in the parks.
