- **Dog and Cat licenses for 2026** can be purchased at the Village Hall or the Humane Society. You have until March 31 to avoid a \$5.00 late fee. Neutered/spayed animals cost \$14.00. If not neutered or spayed, \$24.00. **Cash or check needed for payment.** Thank you!

- **We are accepting Christmas lights until January 30.** Please remove all "extra" items from the lights. String with lights attached are the only acceptable items. Extra bulbs not on strings are not accepted. This may be the last year for collecting lights as we have had to sort through many things that are not acceptable (bulbs and extension cords have been the main items). We are still accepting candles and their containers all year long. Please place items in the boxes located in the entryway of the Village Hall. **THANK YOU!**

WINTERTIME REMINDERS

- Property owners and occupants are responsible for removing snow and ice from sidewalks within 24 hours after the snowfall ceases. There is no minimum snowfall amount rule. All snow needs to be cleared. (Village ordinance 12.07)
- Removing snow from private property and depositing on sidewalks, streets or other public places is prohibited.
- Do you live near a fire hydrant? Please help us to keep it clear of snow. This will allow the fire department quicker access during emergencies. Your assistance is greatly appreciated.
- When ice has formed and cannot be immediately removed, residents should use salt, sawdust or sand to cover the area.
- Sand barrels are available on corner of Verrill and School St., behind the Village Hall and on the corner of Cherry and West Cedar.

The Village of Whiting is not responsible for any damage that may occur within the Village's right-of-way as a result of the snow and ice removal operations. This includes damage to snow sticks, gravel/sand, gouged or torn sod, landscapes, irrigation equipment or driveway aprons. Snow sticks should be set back a minimum of 1 foot from the paved part of the road.

REAL CHRISTMAS TREE PICKUP JANUARY 8

Christmas (real only) Tree pick up will begin Wednesday January 7. Please place tree on curb by 9:00 a.m. with all lights, decorations, tinsel etc. off. Please keep in mind that the tree must be visible, so if we get snow (hopefully the trend of snowfall continues !), please clean the snow off of the tree. All trees should be picked up that Wednesday, Thursday or Friday. Thank you for your cooperation!
