Village Snow Removal

Greetings! As we move into the winter season, a couple of reminders regarding snow removal from the Maintenance Department:

- 1. Please do not place garbage cans in the pubic roadway.
- 2. Please find alternative parking during winter weather events that is not in a public roadway. This hinders the snow removal process.
- 3. Please do not deposit snow in Village right-of-way's when shoveling, snowplowing, or snow blowing your driveway.

During snow events the Maintenance Department and the Village Contractor will work to clear the streets as quickly as possible. At times this may only be one pass down your roadway during large snow events. Once the event is over, we will clear the roadway to the edge of blacktop on both sides. Salting or sanding will be done once snow has finished falling to allow for maximum effectiveness.

Who is Responsible for Trees in the Right-of-Way?

Wisconsin State Statute §86.03(1) addresses who is responsible. "Removal of fallen trees: If any tree falls from adjacent land into any highway, the owner or occupant of the land shall immediately remove the tree from the highway."

In the event that the tree falls into the road, the Village along with the County will do their best to clear it out of the roadway so that it does not impede traffic. However, it is the responsibility of the property owner to clean up debris and remnants.

Contacts for Emergencies:

In the event of any emergencies in the Village which include power lines down, vehicles leaking fluids, fluid spills, car accidents, or smoke in an area from an unknown source, please dial 911. This will be the fastest way to have the correct emergency responders respond to an incident.

For instances outside business hours, please contact the Door County Sheriff's Office Non-Emergency number at 920-746-2400 and press Zero to speak with an On-Duty Dispatcher. They will gather your information and then contact the appropriate Village representative.

Recycling and Brush Dump Site:

The Ephraim Recycling and Brush Dump is located at 10285 Townline Road and is open 24 – 7, yearround for Village of Ephraim residents.

Please no commercial use; including contractors hired by residents for brush or recycling.

Residents may dispose of their yard brush at this location, anytime from April through November.

GUIDELINES FOR RECYCLING:

- All recyclable items shall be put in the same bin, this is called "single stream".
- Recyclable items includes glass, plastic, aluminum, paper, and cardboard.
- Please clean your recyclable bottles and cans and be sure to leave the covers off.
- Unsure if it is recyclable? Be sure that the item displays the recycling triangle. (Example: Carpet = no symbol, therefore it is not recyclable.)



- PLEASE NO GARBAGE!
- The only place recycling should be placed is in the dumpsters—PLEASE DO NOT LEAVE ANY RECYCLING ANYWHERE BUT INSIDE THE BINS.

Safety Reminders:

Greetings, as we move into the colder months of the year a couple reminders for home heating safety from the Fire Department:

- 1. If you're using your fireplace, make sure it has been inspected by a professional and only burn dry wood.
- 2. Have your furnace inspected and serviced.
- 3. During heavy snowfall check your vent pipes for your furnace to make sure they are not covered with snow.
- 4. Maintain working smoke and carbon monoxide detectors on every level of your home.
- 5. If you are using a space heater for small areas maintain a 3-foot clearance around all sides and have it directly plugged into a wall outlet.
- 6. Extension cords should not be used for any heating applications.

Holding Tank Pump-outs/ Septic Inspection & Pump-outs:

Holding and septic tank pump-outs are available for Ephraim residents only. The Ephraim Treatment Plant personnel can schedule a convenient time to pump-out your holding tank, septic tank, or perform your septic inspection. The office can be reached at 920-854-4991.

Water Testing:

Water testing meets all State requirements and is available to anyone; a fee will be determined at the time of scheduling and is based on what tests you request. Water testing kits are available at the Ephraim Treatment Plant 24/7 located at 10285 Town Line Drive. Instructions and forms can be found on the Village website:

Wastewater Plant News:

Please inform your guests that there is no such thing as a flushable wipe. Any type of wipe can build up and cause blockages and expensive repairs in your grinder station, sewer lateral or septic system. Dispose of all wipes (regardless of the packaging labels) and feminine hygiene products in the appropriate trash container.

Sewer Bills:

Village of Ephraim sewer bills are mailed the first week of April, July, October and the third week of December. They are due 30 days from the date of billing.

Premier Resort Area Tax:

Premier Resort Area Tax "PRAT" became effective January 1, 2022.

Those businesses that may be or think they may be subject to PRAT should contact WI DOR. The Village Administration Office is not responsible for telling a business if they will or will not be subject to the tax.

SHORT-TERM RENTAL HOSTS WHO UTILIZE MARKETPLACE PROVIDER SITES (Airbnb, VRBO, etc.):

- Applicable Lodging taxes effective January 1, **2022 – 14%:** State Sales Tax (5.0% WI Sales and Use + .5% County Sales and Use), Local Room Tax 8.0%, and PRAT (Village of Ephraim .5%)
- It is the host/property owner's responsibility to check the lodging taxes generated for all online listings.

Plan Committee:

During the noon working sessions, the Plan Committee continued its work reviewing current Village ordinances and revising them when necessary. We started the review of home designs for the development off Town Line Drive as well as those in the Norwegian Woods development.

A review of the current ordinance regarding construction parking was initiated. The ordinance related to building in the Protected Waterfront Zoning district is also being reviewed.

We are indebted to Brent Bristol for his working knowledge of Village ordinances. Together we work hard to balance keeping Ephraim, Ephraim while allowing new homes to be built and existing homes to be upgraded.

Marinas and Moorings Committee:

The Village Marina operations concluded as scheduled on October 15. The following mild weather provided good conditions for planned changes to the decking on the floating "EL Pier" on the south end of the Firehouse Marina facility. That work led to unplanned but necessary protection of the electrical wires within the pier which, along with re-setting cleats and power pedestals, will be completed over the winter, high and dry on the parking lot.

The middle of November saw another flurry of activity on the Firehouse Marina parking lot. The corner of sidewalk and asphalt near the launch ramp was removed and replaced with concrete, to better support heavy equipment. All are welcomed to stop and check out the (nearly) finished product; it can be walked on, but please heed the parking barriers, to protect the new concrete while it cures and hardens.

Under the off-season guise of hibernation, the M&M Committee will meet as usual over the winter months, preparing for the 2024 season.

We received positive feedback on its impact on drawing driver's attention to speed limits in our Village. Finally, a CPC update would not be complete without reminding everyone of our amazing Fire Department led by Justin and made up of 21 volunteer members. Latest stats include 59 fire calls and 48 EMS calls so far this year.

<u>Village of Ephraim Short-Term Rental "STR"</u> Ordinance:

License Required: No owner shall allow property under their ownership or control to be used as an STR without obtaining and maintaining a Village of Ephraim license.

<u>NOTICE</u>: Ordinance No. 04-2022 became effective on January 1, 2023. The Village of Ephraim STR license will be renewed annually, on or before November 30 of each year.

If your property meets the definition of a short-term rental and has been issued, or would otherwise be subject to a State of Wisconsin Department of Agriculture, Trade, and Consumer Protection (DATCP) <u>Tourist Rooming House License</u> (<u>TRH</u>) your property will be required to obtain a Village of Ephraim STR license.

Fee Schedule: Initial Licensing Fee \$200 - Late fee \$150 - Renewal \$150

Reminder: All parking for Short-Term Rentals "STRs" shall be on property per Ephraim Code of Ordinances. There should be no street parking.

Have a Complaint about a Village of Ephraim Short-Term Rental (STR)?

Please allow the owner or the designated agent the opportunity to rectify the issue. You can use the contact information provided to you via the neighbor notification letter (if the property is in a residential district). If the issue(s) continue, please reach out to the Village of Ephraim to document the matter. Complaints made to the Village of Ephraim must be in writing (no phone calls will be accepted). Written correspondence will allow the Village to maintain a written, accurate record. All communication must be submitted via email and should be directed to bbristol@ephraim.wi.gov IN AN EMERGENCY, CALL 911.

Parking Within the Village:

The Ephraim Fire Department provides fire and emergency protection services within the Village of Ephraim. For first responders to do their job effectively, they need access to the areas where incidents may occur which requires unobstructed roadways to reduce community risk.

In many areas of the Village, due to car and trailer parking, emergency vehicles have been challenged by obstructed roadways. This could delay response time and create safety issues in the future, if not addressed. Village Fire Chief MacDonald stresses that emergency vehicles need to be able to access roadways to travel to their destination as well as when they arrive at their destination, they need to be able to get close enough to any building to effectively deploy essential emergency services.

We ask that you partner in keeping our roads accessible. Short Term Rental "STR" property owners should take the time and review the Village STR ordinance and communicate in advance with all of their guests that it is **NOT** permissible to park cars or trailers on Village streets. All guests must park onsite in the parking spots indicated on the site plan submitted to the Village of Ephraim with their STR application.

If you or your guest(s) are using Village of Ephraim marina facilities (paying to launch their boat or have a transient dock reservation) the Village does offer options for trailer parking. Your guests can obtain this information directly from marina staff when they launch their boats or check in for their transient slips.

Planning a Building or Remodeling Project?

Structures built without an approved permit are subject to a **5X** the penalty fee per day and you may be required to remove the un-permitted item. Please consult with the Zoning Administrator before you build at 920-854-5501 or bbristol@ephraim.wi.gov



Green Tier Ad Hoc Committee:

The Village of Ephraim officially became a Green Tier community in 2019. The impetus behind this committee is to support the other village committees in pursuing sustainable and environmentally sound practices.

Our village staff has moved away from coal tar products when repaving parking lots and we look forward to spreading the word throughout our community. Coal tar products have known carcinogens so when thinking of repaving your driveway, make sure it is NOT a coal tar based product.

We are members of the Green Tier Summit, which meets twice a year. This group includes all of Door County Green Tier communities as we look at what we might accomplish collaboratively rather than as individual communities. Projects ahead include water filling stations, electric vehicle charging stations, composting and plastic reduction.

This was our fourth year of participating in the Door County Big Plant - giving away 500 seedlings to date.

Village of Ephraim Sewer Rate Increase:

On November 14, 2023, the Village of Ephraim Board of Trustees approved the 2024 Fee Schedule. In turn, the Village of Ephraim announced a 7% increase in sewer rates commencing January 1, 2024. There will also be an increase to resident holding tank pump out fees as well as hauler fees.

- Municipal Sewer Rates \$124 Per REU/ Quarter
- Resident Pump out \$101.00 Per Holding Tank
 Pump out for Village Taxpayers.

Municipal sewer is operated whereby rates are set to generate sufficient revenue to cover the budgeted expenses for sewer systems. The increase in sewer rates is necessary due to increasing operating expenses for the municipality's aging sewer infrastructure and to meet current expenses, debt, and upgrades to an aging system.

Ephraim Library Committee:

The 2023 traditional Fyrbal Book Sale was another resounding success. The library's open house during Christmas in the Village generated much interest with many people dropping by to enjoy a cup of apple cider and cookies, listen to the music of Dr. Gary Ciepluch on Clarinet and Kaira Rouer on flute, and collect holiday crafts and books.

As in other years, we helped with Child's Play, the Ephraim Historical Foundation summer program. We also initiated a Story Walk along the harbor. Well received by visitors and locals alike, we highlighted two different books that people could read as they walked along our beautiful shoreline. It was also our first time participating in the Sister Bay Derby races as we sponsored the "Ephraim Book Mobile," driven by Kiel Larsen.

Burn Permits:

Per Chapter 5 of the Ephraim Code of Ordinances the Village Fire Chief issues burn permits.

No burning shall occur until the Fire Chief has issued a permit.

Burn permits are issued for the following:

1. Brush piles and wooden construction debris under certain conditions.

Prohibited types of burning within the Village:

- 1. Garbage
- 2. Asphalt and roofing materials.
- 3. Waste oil or other oily wastes.
- 4. Painted or treated wood including composite wood products.
- 5. All plastic or rubber products.
- 6. Leaf piles.

Capital Projects:

Anderson Dock: The Village Board determined that concrete exploratory borings of Anderson Dock were required to obtain information regarding the thickness, stability, and ascertain the base components of the concrete. Future Election Dates:

- February 20, 2024: Spring Primary
 - The Spring Primary Election on February 20, 2024 will only be held in the Village of Ephraim if necessary.
- April 2, 2024: Spring Election
- August 13, 2024: Partisan Primary
- November 5, 2024: General Election

Polling Location:

Village of Ephraim residents vote at the Village Administrative Office located at 10005 Norway Street, Ephraim WI 54211. Wisconsin municipalities have uniform polling hours beginning at 7:00 AM until 8:00 PM.

Voter Registration:

There are four important elections dates coming up in 2024. Are you registration ready for the next election? If you are unsure about your registration status, please review the following questions to help you get on the right path.

- Has your name changed since the last time you voted?
- Has your address changed since the last time you voted?
- Has it been more than four years since you last voted?

If you answered yes to any of the above, you may need to re-register. Start by visiting https://myvote.wi.gov/en-us/

to verify your registration status. If you need to register and Ephraim is your primary residence, you can do so online on https://myvote.wi.gov/en-us/

or you can stop by the Village Administrative office (10005 Norway Street), Monday through Friday from 8:00 AM to 4:00 PM. Be sure to bring your Driver's License and proof of residence. For more registration information or accepted documents visit https://elections.wi.gov/

to register or contact the Village Clerk at acollak@ephraim.wi.gov or 920-854-5501.

Absentee Voting:

There are several ways to request and vote absentee for registered voters. The request must be made no later than 5:00 PM on the Thursday before the election. Photo ID must accompany your application. Military and permanent overseas voters do not need to provide a photo ID with their request.

Online. You may request an absentee ballot online by visiting https://myvote.wi.gov/en-us/ and clicking "Vote Absentee".

By Mail. Send your complete and signed Application for Absentee Ballot Application form (EL-121 absentee ballot application) and mail it to your municipal clerk's office. The application must be received no later than 5pm on the Thursday before the election.

By Email: send an email (acollak@ephraim.wi.gov) with a copy of your photo ID attached. If you do not attach Application for Absentee Ballot to your email, please provide the following information in the text of your email:

- Your Full Name
- Voting Address
- Specific election for which you would like a ballot **or** if you are requesting for the calendar year.

 Mailing address for the absentee ballot (if different from your voting address)

Deadline for Returning Your Absentee Ballot

Your complete absentee ballot must be delivered no later than 8:00 PM on Election Day. The US Postal Service recommends you mail your absentee ballot one week before Election Day to ensure it arrives in time. You may hand-deliver your absentee ballot to your polling place by 8:00 PM on Election Day.

Permanent Absentee Ballot

Voters who are indefinitely confined, meaning they have a difficult time getting to the polls due to age, illness, infirmity, or disability, may request that a ballot be automatically sent to them for each election. Indefinitely confined voters do not need to provide a photo ID with their absentee ballot request. Voters on the permanent absentee ballot list must vote in each election or they will be dropped from the absentee ballot rolls.

In-Person Absentee Voting: You may vote In-Person Absentee Voting, also known as "Early Voting" – at the Clerk's office beginning the second Monday prior to election day and ending on the Friday before election day. In person absentee voting hours are 8:00 AM until 4:00 PM, Monday – Friday.

Dog Licenses:

Dog licenses are required per County Ordinance. Fees are \$5.50/neutered or spayed, and \$15.50 if not. To receive a dog license, you must provide proof of your dog's rabies vaccination information. Please mail payment and the license application to: Village of Ephraim, PO BOX 138, Ephraim, WI 54211. Your dog license will be mailed to you.
