**MISHICOT SCHOOL DISTRICT REFERENDUM**

Question: Shall the School District of Mishicot, Manitowoc County, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$29,650,000 for the public purpose of paying the cost of a school building and facility improvement project consisting of construction of additions and renovations at the Middle/High School, including for a performing arts center, career and technical education space and a cafeteria/kitchen and classroom, fitness and athletic facility improvements; renovations and construction of an outdoor classroom at the Elementary School; district-wide capital maintenance, safety, security, building infrastructure, roof replacement and site improvements; and acquisition of furnishings, fixtures and equipment.
