10.06. Ward Populations.

The total population of the Town is 1,651. The population of Ward 1 is 717. The population of Ward 2 is 875. The population of Ward 3 is 59. Said population disparity is permitted by Wis. Stat. § 5.15(2)(d) specifically to accommodate the creation of equal supervisor districts, as requested by the County of Walworth.

10.07. Polling Sites.

Darien Town Hall shall be the polling site of Ward 1, Ward 2, and Ward 3.

10.08. Wards Combined for Voting Purposes.

Wards 1, 2, and 3 created above are hereby combined for voting purposes, so as to share the common polling place indicated, and such combined wards shall use common ballot boxes and ballots, and separate returns shall not be maintained for the combined wards at any election, except where separate ballots are required under Wis. Stat. §§ 5.58 to 5.64. Separate ballots shall be maintained for any electors of one or more of the combined wards who are ineligible to vote for any office or referendum for which other electors in the combined wards may vote.
