

RESOLUTION NO. 7 OF 2025
AUTHORIZING THE SALE OF PROPERTY LOCATED AT 21 Main Street

WHEREAS, the Village acquired title to the property located at 21 Main Street, Stamford, New York, Tax Map No. 54.11-1-1.2 (the "Property"), through a tax foreclosure proceeding; and

WHEREAS, Sue Denkewitz, the former owner of the Property, has requested that it be allowed to repurchase the Property; and

WHEREAS, the Village of Stamford has calculated that the total amount of **\$34,715.61** is owed, pursuant to the foreclosure proceeding, which amount includes back taxes owed to the Village and the County of Delaware, as well as all foreclosure costs incurred by the Village; and

WHEREAS, the Village Board of Trustees has determined that it is in the best interest of the Village to sell the Property to said entity, provided all conditions set forth herein are met.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of the Village of Stamford as follows:

1. **Authorization of Sale:**

The Mayor of the Village of Stamford is hereby authorized to execute a quitclaim deed to convey the Property located at 9 Roosevelt Ave, Stamford, New York, Tax Map No. 54.11-1-1.2, to Sue Denkewitz, for the sum of \$34,715.61.

2. **Execution of Additional Documents:**

The Mayor is further authorized to execute any and all additional documents necessary to complete the sale of the Property to Sue Denkewitz

3. **Conditions of Sale:**

- a. The purchase price shall be paid in full by Sue Denkewitz, prior to the delivery of the quitclaim deed.
- b. Sue Denkewitz, shall be responsible for payment of all transfer taxes, filing fees, and recording fees associated with the conveyance of the Property.

4. **Delivery of Deed:**


Upon receipt of the full purchase price, the Mayor shall execute and deliver a quitclaim deed to Susan Denkewitz, conveying the Property.

RESOLUTION NO. 6 OF 2025
AUTHORIZING THE SALE OF PROPERTY LOCATED AT 9 ROOSEVELT AVE

WHEREAS, the Village acquired title to the property located at 9 Roosevelt Ave, Stamford, New York, Tax Map No. 54.6-1-10 (the "Property"), through a tax foreclosure proceeding; and

WHEREAS, Aree Bray, the former owner of the Property, has requested that it be allowed to repurchase the Property; and

WHEREAS, the Village of Stamford has calculated that the total amount of **\$21,335.01** is owed, pursuant to the foreclosure proceeding, which amount includes back taxes owed to the Village and the County of Delaware, as well as all foreclosure costs incurred by the Village; and

WHEREAS, the Village Board of Trustees has determined that it is in the best interest of the Village to sell the Property to said entity, provided all conditions set forth herein are met.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of the Village of Stamford as follows:

1. Authorization of Sale:

The Mayor of the Village of Stamford is hereby authorized to execute a quitclaim deed to convey the Property located at 9 Roosevelt Ave, Stamford, New York, Tax Map No. 54.6-1-10, to Aree Bray, for the sum of \$21,35.01.

2. Execution of Additional Documents:

The Mayor is further authorized to execute any and all additional documents necessary to complete the sale of the Property to Aree Bray

3. Conditions of Sale:

- a. The purchase price shall be paid in full by Aree Bray, prior to the delivery of the quitclaim deed.
- b. Aree Bray, shall be responsible for payment of all transfer taxes, filing fees, and recording fees associated with the conveyance of the Property.

4. Delivery of Deed:


Upon receipt of the full purchase price, the Mayor shall execute and deliver a quitclaim deed to Aree Bray, conveying the Property.
