WHEREAS, in the minutes of the June 11, 2019, Town of Stella Board Meeting, Camp Horseshoe requested rumble strips to slow down traffic, and Camp Horseshoe would pay for the rumble strips; and

WHEREAS, in the minutes of the July 9, 2019, Town of Stella Board Meeting, Supervisor Goodin received a call from a resident of Meadow Lane and this resident reported an issue with the rumble strips in front of Camp Horseshoe that the board approved and gave permission for; and

WHEREAS, further in the minutes of the July 9, 2019, Town of Stella Board Meeting, Supervisor Goodin discussed that it is a safety issue for the children crossing and cars going very fast in front of Camp Horseshoe; and






