

**TOWN OF NASEWAUPEE**  
**Resolution No. 2024-03**  
**Schedule of Fees and Penalties**

**WHEREAS** the Town of Nasewaupee has adopted a Code of Ordinances subject to revision from time-to-time;

**AND WHEREAS** the Town of Nasewaupee Code of Ordinances refers in multiple locations to a schedule of fees and penalties;

**NOW, THEREFORE**, be it therefore resolved by the Town Board of the Town of Nasewaupee that the following schedule of permit fees and penalties shall be in effect until further action of the Town Board of the Town of Nasewaupee.

A. Penalty Provisions.

1. General Penalties. Whenever so provided in the Code of Ordinances, any person or entity which violates any of the provisions of the Code of Ordinances shall, upon conviction of such violation, be subject to a penalty which shall be as follows unless a specific penalty is set forth for such violation:

(a) First Offense. Any person or entity who shall violate any provision of the Code of Ordinances, unless otherwise provided, shall, upon conviction thereof, forfeit not less than \$10 nor more than \$200, together with the costs of prosecution and court costs, and in default of payment of such forfeiture and costs shall be imprisoned in the county jail until such forfeiture and costs are paid.

(b) Second Offense. Any person or entity who shall violate any provision of the Code of Ordinances who has previously been convicted of a violation of the same provision shall, upon conviction thereof, forfeit not less than \$20 nor more than \$500 for each such offense, together with the costs of prosecution and court costs, and in default of payment of such forfeiture and costs shall be imprisoned in the county jail until such forfeiture and costs are paid.

2. Continuing Violations. Each violation and each day a violation continues or occurs shall constitute a separate offense. Nothing in the Code of Ordinances shall preclude the Town of Nasewaupee from maintaining any appropriate action to prevent or remove a violation of the Code of Ordinances.

3. Schedule of Deposits.

(a) Generally. Cash deposits for violations of the Municipal Code of Ordinances are to be made to the Town Treasurer or Door County Clerk of Court. Cash deposits for violations of ordinances of this Municipal Code shall be as set forth below:
