Miscellaneous Tax Information:

- Refunds will be issued if escrow checks are in excess of the **total** taxes due.
- Escrow checks that are short of the amount due, will receive a receipt showing the property owner what is due to pay the parcel in full.

Dog Licenses

(Due by April 1, 2026 OR \$5.00 late fee PER DOG will apply)

Neutered or spayed dog	\$5.00
Intact male or female	\$10.00
Kennels (First 12 dogs)	\$35.00

*Please note that dog licenses will need to be paid separately from the property tax payment and will only be issued by the Town of Nasewaupee. Please **do not** send your dog license information with your tax payment to the Door County Treasurer. You may still mail in dog license payments & proof of vaccination to the Treasurer, Town of Nasewaupee at 3388 County PD Sturgeon Bay, WI 54235.*

In Person Dog Licensing at Town Hall: Friday December 12th Noon-3pm, Friday January 9th Noon-3pm, and Thursday February 19th 4-6pm (hard stop at 6pm for monthly Town Board Meeting). If you plan to pay with cash please bring the exact change if possible.

State law requires a dog license for the keeping of any dog over 5 months of age. Owners must present proof that their dogs are vaccinated against rabies by a veterinarian before the dogs can be licensed. This proof should include date of vaccination, date of expiration, rabies vaccine manufacturer, and rabies serial number. Please also be sure to include owner name and address of the location of dog in the Town of Nasewaupee.

Wis. Stat. § 174.05(15) Any person who violates this chapter shall be fined not more than \$500 or imprisoned up to 60 days or both.

LEGAL NOTICE

Short Term Rental License

The Town of Nasewaupee enacted Ordinance 2021-08 – An Ordinance Amending the Town of Nasewaupee Municipal Code Regulating Short Term Rentals (STR). The purpose of the ordinance is to balance the interests of property owners to use their property as short term rentals, on the one hand, with the interests of residents who seek to protect the quality of life and the character and stability of neighborhoods, on the other hand. Beginning in 2022 no person may maintain, manage, or operate a STR more than ten (10) nights each year without a Town STR License. Reminder – Current License Holders: STR Licenses expire December 31st. To avoid fines, fees, and penalties please complete your online renewal application(s). You can renew your license(s) 45 days prior to the expiration date and up to, but not later than, 45 days following the expiration date. STR licensees will need to update their Property Rules to reflect a new non-emergency Fire Department phone number - Nasewaupee Fire Rescue (920)743-1833.

Door County Tourism Zone

Any innkeeper or other property owner offering transient rental (less than 30 days) must obtain a permit and collect 8% room tax (per WI State statute, local ordinance, and the Door County Tourism Zone Intergovernmental Agreement).
