RESOLUTION AWARDING CONTRACT FOR FURNISHING AND DELIVERY OF
WATER METERS TO THE BOROUGH OF BUENA MUNICIPAL UTILITIES AUTHORITY
TO RIO SUPPLY, INC.

WHEREAS, the Borough of Buena Municipal Utilities Authority (hereafter the “Authority”) has arranged for the publication of specifications and terms for the furnishing and delivery of water meters to the Authority for February 11, 2017 to February 10, 2019; and

WHEREAS, the Authority’s Engineer, Remington, Vernick & Walberg, as required by law, caused to be published specifications for the bidding of such work in accordance with the relevant New Jersey Statute prescribing publication in such matters; and

WHEREAS, it is necessary and proper that the Authority confirm all action taken by its Engineer, any publication of the specifications seeking bids; and

WHEREAS, upon proper application, bids were received, open and read on December 6, 2016 at 11:00 a.m. by the Authority at the Borough of Buena Municipal Building located at Central Avenue in Minotola, New Jersey; and

WHEREAS, Rio Supply, Inc. having its principal place of business at 100 Allied Parkway, Sicklerville, New Jersey 08081, submitted the lowest responsible bid in the amount of \$44,100.00 for the furnishing and delivery of water meters; and

WHEREAS, the Authority’s Engineer, Remington, Vernick & Walberg has recommended that the Authority accept the lowest responsible bid as submitted by Rio Supply, Inc.; and

WHEREAS, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that all action taken by the Authority’s Engineer, Remington, Vernick & Walberg, in publishing specifications for bids and the

subsequent action taken by the Authority, in respect to its acceptance of the lowest responsible bid for the published services, be and these actions are hereby confirmed and approved.

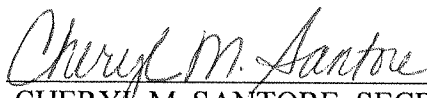
