MICRO C 1000 TO THE BOROUGH OF BUENA MUNICIPAL UTILITIES AUTHORITY
BY GEORGE S. COYNE CHIMICAL CO., INC.

WHEREAS, the Borough of Buena Municipal Utilities Authority (hereafter the “Authority”) had arranged for the publication of specifications and terms for the furnishing and delivery of Micro C 1000 to the Authority for January 1, 2017 to December 31, 2018; and

WHEREAS, the Authority’s Engineer, Remington, Vernick & Walberg, as required by law, caused to be published specifications for the bidding of such work in accordance with the relevant New Jersey Statute prescribing publication in such matters; and

WHEREAS, it is necessary and proper that the Authority confirm all action taken by its Engineer, any publication of the specifications seeking bids; and

WHEREAS, upon proper application, bids were received, open and read on December 6, 2016 at 11:00 a.m. by the Authority at the Borough of Buena Municipal Building located at Central Avenue in Minotola, New Jersey; and

WHEREAS, George S. Coyne Chemical Co., Inc. having its principal place of business at 3015 State Road, Croydon, Pennsylvania 19021-6997, submitted the lowest responsible bid in the amount of \$43,401.60 for the furnishing and delivery of Micro C 1000; and

WHEREAS, the Authority’s Engineer, Remington, Vernick & Walberg had recommended that the Authority accept the lowest responsible bid as submitted by George S. Coyne Chemical Co., Inc.; and

WHEREAS, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

WHEREAS, all action taken by the Authority’s Engineer, Remington, Vernick & Walberg, in publishing specifications for bids and the subsequent action taken by the Authority,

in respect to its acceptance of the lowest responsible bid for the published services, be and these actions were hereby confirmed and approved on December 14, 2016 and the proper officers of the Authority be and they were hereby authorized to execute any and all documents required with respect to the awarding of a contract for the furnishing and delivery of Micro C 1000 to George S. Coyne Chemical Co., Inc.; and

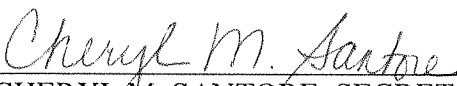
WHEREAS, the contract documents were not signed by both parties prior to the date of January 1, 2017 but were however signed on January 25, 2017;

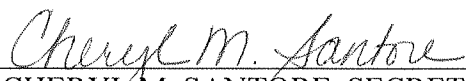
