WHEREAS, upon proper application, bids were received, open and read on July 11, 2017 at 11:00 a.m. by the Authority at the Borough of Buena Municipal Building located at Central Avenue in Minotola, New Jersey; and

WHEREAS, Emerald Equipment Systems, Inc., having its principal place of business at 7600 Morgan Road, Liverpool, New York 13090, submitted the lowest responsible bid in the amount of \$118,500.00 for the furnishing and delivery of a sludge composting screening system with an alternate bid no 1 (deducting the salvage value) of \$113,500.00; and

WHEREAS, the Authority's Engineer, Remington, Vernick & Walberg has recommended that the Authority accept the lowest responsible bid as submitted by Emerald Equipment Systems, Inc.; and

**WHEREAS,** the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that all action taken by the Authority's

Engineer, Remington, Vernick & Walberg, in publishing specifications for bids and the

subsequent action taken by the Authority, in respect to its acceptance of the lowest responsible

bid for the published services, be and these actions are hereby confirmed and approved.

BE IT FURTHER RESOLVED that the Secretary of the Authority is hereby authorized

to return all bids, certified checks and/or bid bonds to any and all rejected bidders.

BE IT FURTHER RESOLVED that the proper officers of the Authority be and they are

hereby authorized to execute any and all documents required with respect to the awarding of a

one-time contract fee in the amount of \$113,500.00 for the furnishing and delivery of a sludge

composting screening system.
